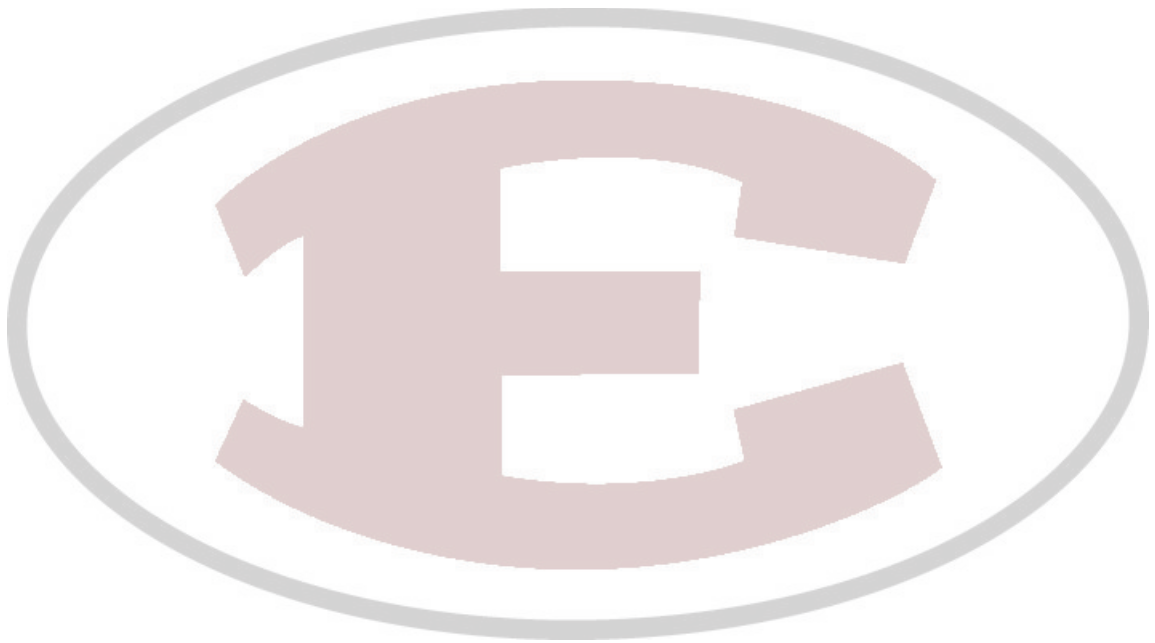

I. INTRODUCTION

House Bill 1842 was passed during the 84th Legislative Session. This bill provides the opportunity for Texas public school districts to pursue becoming a District of Innovation, which allows districts to obtain exemptions from certain provisions of the Texas Education Code to allow more flexibility and local control for innovative programming.

District of Innovation provides opportunities for:

- Greater local control
- Increased flexibility governing education programming
- Empowerment to innovate and think differently.

Districts are not exempt from statutes related to curriculum, graduation requirements, nor academic and financial accountability.

ENNIS ISD MISSION STATEMENT

IV. TERM

The term of the District of Innovation Plan will be in place for the 2017 – 2018 school year through the 2021 – 2022 school year unless amended or terminated by the Board of Trustees in accordance with the law. The Ennis ISD District of Innovation Committee will revisit the plan annually to ensure that the recommendations still meet the needs of the district. Any recommended changes will be posted on the website for 30 days for feedback and require approval of the Ennis ISD District of Innovation Committee, the EISD DWC Committee, and the Board of Trustees.

V. EISD DISTRICT OF INNOVATION PLAN

The District proposes flexibility in the following areas:

CTE Teacher Certification

Texas Education Code: [Sec. 21.003](#). CERTIFICATION REQUIRED

"A person may not be employed as a teacher, teacher intern or teacher trainee, librarian, educational aide, administrator, educational diagnostician, or school counselor by a school district unless the person holds an appropriate certificate or permit issued."

Rationale: Ennis ISD believes school district leadership should decide what is best for its students in determining the candidate best suited to teach career and technical education (CTE) courses.

School Calendar

Texas Education Code: [Sec. 25.0811](#) FIRST DAY OF INSTRUCTION

"a school district may not begin instruction for students for a school year before the fourth Monday in August."

Texas Education Code: [Sec. 25.0812](#) LAST DAY OF SCHOOL

"a school district may not schedule the last day of school before May 15."

Board Policy:

EB: SCHOOL YEAR

Rationale: Ennis ISD believes the local community should decide what is best for its students in setting the first day of instruction and the last day of school. By claiming exemption from [Sec. 25.0811](#) and [Sec.25.0812](#), the district shall determine the first day of instruction and the last day of school for its students on an annual basis with input from stakeholders. Local control of the instructional calendar affords the District the following advantages:

- Elimination of imbalanced 9 weeks and semester schedules while still ending the first semester prior to the holiday break.
- Alignment of calendar with dual credit courses, Advanced Placement Exams, and STAAR/EOC timelines.
- Creates flexibility for the District to pursue year round school of choice for identified populations.

Regardless of whether any adjustments or changes are made to the current start date law, Ennis ISD believes this issue to be a local decision as opposed to a state mandate.
