Features

- ♦ Used to pay for Tech Fees, Activity Tickets, Lunch Money, MS Yearbooks, Prom Fees, etc.
- ♦ **Send payments faster** and directly to your child's meal accounts: Payments are credited within 10 minutes.
- ♦ **Mobile Applications:** EZSchoolPay app is available for iPhone, iPad, and Android devices. Receive alerts of low balances, make payments for your child's meal account, and pay your school fees.
- ♦ **Low Balances:** Receive alerts when your child's balance drops below a certain balance.
- ♦ Accepts **Visa, MasterCard, and Discover** credit or debit cards.

- ♦ Click SAVE
- ♦ Once you register, an email will be sent to the address provided. You must go to your email and click the link provided from EZSchoolPay.com to validate your account.
- ♦ Once your account is validated, you may begin using your EZSchoolPay account.

Frequently Asked Questions - Applying Online

Q: How will I know that the meal application was received by the district?

A: As soon as the application is submitted with all of the required information, a unique confirmation number is automatically emailed as receipt by the school district. An eligibility determination must be made and implemented within 10 operating days of the receipt of the application.

Q: How will I know that the application was approved?

A: A notification letter will be emailed to the email address provided.

Q: How much time does it take to complete the application online?

A: In general, it takes 15-30 minutes to apply, based on the size of your household.

Q: How do I know the EZMealApp site is secure?

A: EZMealApp has security measures in place to protect the loss, misuse, and alteration of the information under their control. The system is fully compliant with all security regulations and information is protected by the highest security standards using a Secure Socket Layer (SSL) protocol. Your information will never be sold or published. The information provided is only used to determine eligibility. The Ethnic/Racial section & the Date of Birth/Student ID fields are optional when filling out an application. If an ethnic/racial selection is not made, one will be made for you based on visual observation.

The **Richard B. Russell National School Lunch Act** requires the information on this application. You do not have to give the information, but if you do not submit all needed information, we cannot approve your child for free or reduced price meals. You must include the last four digits of the social security number of the adult household member who signs the application. The social security number is not required when you apply on behalf of a foster child or you list a Food Assistance (FA), Family Investment Program (FIP) or Food Distribution Program on Indian Reservations (FDPIR) case number or other FDPIR identifier for your child or when you indicate that the adult household member signing the application does not have a social security number. We will use your information to determine if your child is eligible for free or reduced price meals, and for administration and enforcement of the lunch and breakfast programs. We may share your eligibility information with education, health, and nutrition programs to help them evaluate, fund, or determine benefits for their programs, auditors for program reviews, and law enforcement officials to help them look into violations of program rules.
