## Q. What are we voting on?

There will be one question on the November 5, 2024 ballot.

#### Question | Non-recurring Operating Referendum |

**The Non-recurring Operating Referendum** is structured: \$4.25 million in the 2025-2026 school year to scale to \$4.5 million in the 2026-2027 school year and then in 2028 and 2029, \$4.75 million for non-recurring purposes consisting of maintaining educational programs, staff and facilities.

### Q. Why do we need the question?

The Question is an operating question; it asks voters for permission to exceed the revenue limit for the purpose of funding annual school operations such as employee wages and benefits, utilities, technology, and support for student programming. This operating question is a continuation of an operational referendum that was initially supported in 2008, and renewed in 2011, 2013, 2015, 2018, and 2020.

#### Q. What is the estimated tax impact of the referendum questions?


Based on preliminary equalized values for our district, the mill rate will **decrease** in 2024-2025 by \$.60 and then if the resolution is approved, the mill rate will remain relatively unchanged for the next four years.

#### Q. How does Sevastopol's mill rate compare to neighboring districts?

Currently, the District's mill rate, which is used to calculate property taxes, is one of the lowest in the state and below the state average.
