<u>Board Candidate Filing</u> – Leah Martin, Jennifer Thomas, Andrea Harris and Andy Gorsage have filed as candidates for the Drexel R-IV Board of Education.

<u>Legislative Breakfast</u> – Cass County Kids First will host its' first legislative breakfast of the year on Friday, March 6th at the Ray-Pec School District Administrative Center. Breakfast begins at 7:30 AM and the program begins at 8:00 AM. Let me know if you are interested in attending. I have to RSVP by March 2nd.

<u>District Basketball</u> – the Class 1 District 6 Basketball Tournament will be held during the week of February 24th at Rich Hill.

Legislative Updates:

Charter schools and education savings accounts (vouchers) are seeking to privatize public education using taxpayer money, with no accountability for the education received! These bills could be voted on in the Senate any day now.

Education Savings Accounts:

<u>SB 581</u> (Cierpiot) creates the "Show Me Brighter Future Scholarship Program," another name for an Education Savings Account or voucher. This program would divert \$50 million of public funds to private schools with no mechanism to ensure that students are receiving a quality education.

Charter School Expansion

There are three charter school bills moving:

- * <u>SB 525</u> (Emery) Creates charter high school in the KC School District for students in recovery from substance abuse. Nonresident students may attend at the expense of the resident school district.
- * <u>SB 603</u> (O'Laughligh) Expands charter schools to schools in Jackson, St. Charles, St. Louis and Jefferson Counties and in cities with a population greater than 30,000. It also allows nonresident students to attend at the expense of the resident school district.
- * <u>SB 649</u> (Eigel) Similar to SB 603 except it excludes expansion of charter schools in accredited districts with 3,000 or fewer students.

House Committee hears, approves bills

The House Elementary and Secondary Education Committee heard the following bills this week: <u>HB 1682</u> (Wood), a bill that prohibits vapor product usage in indoor areas of public schools or on school buses; and <u>HB 1808</u> (Wood), a bill requiring school districts to include instruction on the use and effects of vapor products. The committee also heard <u>HB</u>

1818 (Dinkins), a bill that modifies the definition of "local effort" regarding school funding by removing fines from the calculation.

The committee voted out <u>HB 1347</u> (Baker), a bill that prohibits the use of public funds to support or oppose candidates and ballot issues and restricts individuals from advocacy before the General Assembly. The committee also approved <u>HB 1903</u> (Shields), a bill that provides additional \$30,000 in state aid to school districts that share superintendents.

School board recall bill filed

A bill has been filed in the Missouri House that establishes a procedure for school board member recall elections. The bill is <u>HB 2360</u> (Basye). It would allow for a recall election of a school board member if a petition is filed with signatures from voters equal to 25% of those voting in the most recent school board election.
