

# Greenlee Elementary School

## Parental Involvement Policy

### I. POLICY INVOLVEMENT

The Parent Involvement Plan is jointly developed with, agreed upon with, and distributed to all parents. ### III. BUILDING CAPACITY FOR INVOLVEMENT

To ensure effective involvement of parents and to support a partnership among the parents, community and school to improve student achievement, we will:

- a. Assist parents in understanding Mississippi's academic and achievement standards by disseminating pamphlets and hand-outs (Parents' Right to Know, Federal Programs Guide, Child Find under IDEA 2004) and by conducting Parent-Teacher conferences, parent workshops, and Open Houses.
- b. Communicate and monitor a child's progress by interim report cards every 4 ½ weeks of the nine weeks, reports cards every nine weeks, IEP meetings, weekly/monthly telephone calls, AIMS messaging and class texts through Remind, parent-teacher conferences and ActiveParent website.
- c. Assist parent in helping them to improve achievement of their children through a monthly newsletter that provides activities and suggestions, parent-teacher communicators with daily and weekly assignments, and conducting parent workshops.
- d. Educate teachers and other staff members, with the assistance of parents, in

reaching out to, communicating with, and working with parents through PTO, conferences, workshops, and staff development

- e. Send information related to school and parent programs, meetings, and other activities to the parents in a format and language they can understand through teacher generated letters, PTO meetings school calendar, parent/student handbook, parent-teacher communicator and ActiveParent website.
- f. Provide opportunities for parents to communicate with the school through an open door policy, parent-teacher communicators, designating time to meet with principal and/or teacher, and parent workshops.

Greenlee Elementary School shall hold meetings for parents and community members at various times to accommodate stakeholders. These meeting will be publicized by multiple means: flyers sent home with students, Flyers posted in public places such as doctors' offices, grocery stores, public library. Meetings will be posted on district web page, school web page, and in local radio stations web pages and Local newspaper. Parents will also be notified through Remind text messages from teachers, School/District Facebook, AIMS 2.0, and the schools messaging system.

- 2. Offering a flexible number of meeting and parent trainings at convenient times for parents to participate, give suggestions, and take part in decision regarding the instructional program of the school.**

Greenlee Elementary School shall hold meeting for parents and community members at different times of the day and different days of the week to accommodate all stakeholders. These meetings will be publicized by multiple means: flyers sent home with students, Flyers posted in public places such as doctors' offices, grocery stores, public library. Meetings will be posted on district web page, school web page, and in local radio stations web pages and Local newspaper. Parents will also be notified through Remind text messages from teachers, School/District Facebook, AIMS 2.0, and the schools messaging system.

- 3. Parents are involved in and “organized, ongoing, and timely way,” in the planning, review and improvement of the Parental Involvement Policy and Title I Programs. Parents will receive timely information about Title I Programs.**

Greenlee Elementary School Shall hold meeting for parents and community members, these stake holders are selected as members of the Greenlee Elementary Schoolwide improvement committee. These annual meeting will be for review of programs and planning for the upcoming year's programs. This Committee is involved with the Parent-Teacher-Compact, parental involvement policy, and the federal programs application and budget. Notices of meetings will be posted on schools web page, local media and send out through AIMS 2.0. Notices will also be sent out through REMIND the teachers group text messaging system. Agenda, minutes and sign-in sheets will be kept on file of these meetings.

Greenlee Elementary School provides a copy of the schoolwide plan to parents and other stakeholders at every opportunity available. The school wide plan is kept on file at the school principal's office, the superintendent's office and in each school library. In the Federal Program planning annual meeting each parent is provided a feedback form. These forms are compiled and used when the committee is reviewing the schoolwide plan each year. Greenlee Elementary School Federal Programs committee reviews this compact each year and makes necessary changes to reflect the commitment of all stakeholders.

Attala County School District provides professional development which includes training in technology and curriculum. Greenlee Elementary School will provide training for parents in technology and other areas. Regular parent meeting are held throughout the school year to help keep parents informed and provide opportunities for parents to ask questions concerning the curriculum and academic progress of their children. Greenlee Elementary School will send news letters home to stakeholders concerning information about federal programs state curriculum content standards, and how to improve student achievement.

- 8. Will provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children, including providing information and school reports required under section 1111 in a format and, to the extent practical, in a language such as parents understand.**

Greenlee Elementary School will send home letters to stakeholders concerning information about Federal Programs in native languages. Regular parent meetings are held throughout the school year to help keep parents informed and provide opportunities of parents to ask questions concerning the curriculum and academic progress of their children. Greenlee Elementary employs a teacher who is fluent in Spanish, they will provide translation at meetings for a parent whom that is required.
