



THOMAS & JULANNE HAGEWOOD EDUCATIONAL SCHOLARSHIP

The Thomas & Julanne Hagewood Educational Scholarship was established in their memory by their sons Thomas Hagewood III, Roger Hagewood, and Martin Hagewood. <u>This scholarship is to be awarded to a graduating Clarinda High School Senior that plans</u> to major in Education (teaching) with preference given to those that plan to attend <u>Northwest Missouri State University in Maryville, Missouri. Special consideration will</u> be given based on need, scholarly achievement, character and reputation.

Thomas Hagewood, Jr. was born October 29, 1928 in Detroit, Michigan and passed away at the age of 90 on March 21, 2019 in Clarinda, Iowa. Tom served in the Army Air Corp in Guam during World War II. Tom attended Clarinda Community College and received an Associate's Degree. He then attended Northwest Missouri State University (NWMSU) in Maryville, Missouri earning a Bachelor of Science degree in education and a Masters degree in administration.

Julanne Hagewood was born April 27, 1928 in Iowa City, Iowa and passed away at the age of 53 on March 22, 1982 at Clarkson Hospital in Omaha, Nebraska. Julanne was the adopted daughter of Elijah and Mertie Stipe of Clarinda. A 1946 graduate of the Clarinda High School, Julanne attended Clarinda Community College and later NWMSU where she earned a Bachelor's Degree in Education and a Master's Degree in Education with an emphasis on early reading skills.

Tom and Julanne were united in marriage on October 25, 1947 in Detroit, Michigan. The couple began their teaching careers in Ute, Iowa in 1958. After their first year of teaching in Ute, both accepted positions within the Clarinda School District. Tom taught seventh and eighth grade math in Clarinda for thirty-three years retiring in 1989. His additional duties included coaching of all sports throughout his career. Julanne taught first grade at Garfield School for 21 years before her illness forced her to retire in 1979.

The following guidelines will be used in making the scholarship selection:

- 1. The scholarship shall be used to help pay the cost of any college program leading to a degree in education (teaching).
- 2. The Clarinda Foundation shall disburse the scholarship grant to a college or university indicated by the recipient in one payment prior to the beginning of the fall semester of year in which the scholarship is awarded.
- 3. The selection committee shall consist of a minimum of five individuals: 1) one individual named by the Foundation (who shall serve as chair of the Committee); 2) the Clarinda High School (CHS) Principal, 3) the CHS Guidance Counselor, 4) one CHS faculty member, and 5) a Hagewood family representative.
- 4. The selection committee reserves the right to not award the scholarship should they determine that no applicant is worthy.
- 5. The application must be typed or computer generated and shall include an essay addressing the following:
 - a. Applicant's intended major <u>shall be education (teaching)</u> and why the applicant has chosen this major.
 - b. Applicant's contributions to the Clarinda High School and the community.
 - c. Applicant's work history.
 - d. Applicant's extracurricular activities.
- 6. The scholarship shall be awarded without regard to race, color, creed, gender, nationality, origin or physical handicap.
