2024 High School Summer School Program

INSTRUCTIONAL PROGRAMS

Calvert County Public Schools (CCPS) offers high school courses during the summer delivered online or in a traditional setting.

ONLINE COURSES – (original and review credit) – CCPS offers online Financial Literacy, Foundations of Technology, Foundations of Computer Science, Health I, Health II, Music Appreciation, Spanish I, and Spanish II. Students must attend a synchronous orientation meeting using Microsoft Teams on the first day of the course. Some courses may require students to meet with the instructor up to three additional times during the summer term. Students who request to take an online course must complete the Online Learning Interest Survey. TRADITIONAL REVIEW COURSES – Courses are offered to students who did not successfully complete a course in which they had been enrolled during the regular school year. Certified teachers provide targeted instruction related to students' specific learning deficits.

ADMISSIONS POLICY – These courses are available only to students enrolled in a CCPS high school course during the 2024–2025 school year. Public and private school students may attend CCPS summer school.

SUMMER SCHOOL COURSES

The CCPS high school summer school program for traditional review courses will be held at the **Career & Technology Academy from July 8 – August 1, 2024**. These courses will be **Monday – Thursday for 3 hours and 45 minutes** per course. Morning and afternoon sessions will be offered if there is sufficient enrollment. The sessions will be held from either **7:30 am to 11:15 am or 11:45 am to 3:30 pm**.

The following courses will be offered:

ONLINE COURSES – These online courses may be taken for original or review credit. Online courses will begin on June 24 and will end on August 1. These courses require synchronous Teams meetings on the dates below. Tentative dates are listed but are subject to change. The course instructor will communicate the required virtual meetings.

- Financial Literacy (must attend the first meeting and at least 2 others) 6/24+, 7/3, 7/10, 7/17, 7/24, 8/1
- Foundations of Technology (must attend the first meeting and 2 others) 6/24+, 7/3, 7/10, 7/17, 7/24, 8/1
- Foundations of Computer Science (must attend the first meeting and 2 others) 6/24+, 7/3, 7/10, 7/17, 7/24, 8/1
- Health I (must attend the first meeting and at least 4 others) 6/24+, 7/3, 7/10, 7/17, 7/24, 8/1
- Health II (must attend the first meeting and at least 4 others) 6/24+, 7/3, 7/10, 7/17, 7/24, 8/1
- Music Appreciation (Rising seniors only) [must attend 6/24+
- Spanish I (must attend first and last dates) 6/24+ and 8/1+
- Spanish II (must attend first and last dates) 6/24+ and 8/1+

Traditional Review Course Registration: The Summer School Registration Form for Traditional Review Courses may be obtained at each high school or found on the [CCPS website](#). **Registration for traditional review courses begins on June 3, 2024.** Approval and submission of the [Summer School Registration Form](#) are required before registration may be completed. Printed Summer school registration forms should be submitted to the student's home school. Students not enrolled in a CCPS high school may return the registration form in person or mail the form to the summer school office at Career & Technology Academy 330 Dorsey Rd. Prince Frederick, MD 20678. Final class schedules for traditional review courses are determined from the registration data available on June 24, 2024. Time limitations preclude the mailing of class acceptance notices to students. Class lists will be available by phone or in person at the summer school office at the Career & Technology Academy on July 3, 2024.

ATTENDANCE REQUIREMENTS

Since summer school lasts for only 16 days, participating students must maintain excellent attendance. **Credit will be denied if a student misses more than two class periods.** Students who cannot attend all classes should not enroll in credit courses. Students are also required to be on time for every class.

TUITION

There is no charge to enroll in a review course for Summer 2024. Students enrolling in an online course for original credit course would be charged \$225.00 for a half-credit course and \$325.00 for a full credit course (this includes a \$25.00 non-refundable application fee). Courses for original credit are limited and priority of enrollment will be given to upperclassmen.

- CCPS Public School Student Tuition is waived
- Private School/Non-County Resident Review Credit: \$250.00. Online Courses: \$275.00/\$375.00

*A non-resident is a person who is permanently located outside Calvert County during the regular academic year.

Full tuition for online courses must be paid by June 14, 2024. **Checks are to be made payable to Calvert County Public Schools.** If a student withdraws from a course after attending one or more classes, **no tuition will be refunded.** However, if a course is canceled, the full tuition will be refunded.

TRANSPORTATION

Calvert County Public Schools **does** provide transportation during the summer term.
