# A. Approve new Environmental Science Course

**Background:** Students need to take three years of science to meet the requirements of the Michigan Merit Curriculum for graduation. This course would provide a science credit option that is not advanced/college bound. Incoming 9th graders earn a science credit from Chemistry I and Physics I. 10th graders earn a credit from Biology. 11th-12th graders can earn credit from Chemistry II, Physics II, Anatomy & Physiology, AP Biology, or AP Chemistry. Environmental Science will provide another standards (NGSS) based elective course.

Motion by Holstege, seconded by Hendricks, to approve the request to create an Environmental Science elective course for high school juniors and seniors as presented. Motion carried.

## B. Approve new Advanced Residential Structures Course

**Background:** Advance Residential Structures is a hands-on course that further builds on the concepts and fundamentals from Introduction to Residential Structures. This class is intended for students who have an interest in the construction career pathway and may provide occupational employment opportunities available in the construction industry. The class will have an advanced focus on residential construction techniques in the areas of: proper hand and power tool uses, blueprint reading, framing, roofing framing, electrical wiring, drywall, interior finishes, industry terminology and math concepts.
