Board President, Mark Huntington called the meeting to order at 7:00 p.m. Members present were Witney Allen, Joanne Langworthy, Mark Huntington, KY Cole, and Hannah Nolte. Motion by Cole, seconded by Allen to approve minutes from the June 26, 2024 regular board meeting. Motion carried 5-0.

Motion by Allen, seconded by Langworthy to approve the FY24 General Fund encumbrances # 2023-2062 in the amount of \$71,683.95, FY25 General Fund Purchase orders #1-228 in the amount of \$3,201,053.40, FY25 Building Fund encumbrances #1-6 in the amount of \$4,642.59, Bond Fund #31 purchase order #1 in the amount of \$5,000, Bond Fund #32 purchase orders #1-2 in the amount of \$119,558.98 and Bond Fund #32 encumbrance #1 in the amount of \$55,595.00 Motion carried 5-0.

HEARING FROM THE PUBLIC: Karen Auer, HS Counselor spoke about her satisfaction with our Administration. Auer also spoke about the no cell phone policy, stating cell phones cause anxiety and depression in the students. Linda Uselmann, teacher spoke about the negative impact cell phones have on the students, she stated cell phones are a distraction, aid in bullying and parents texting can be a problem also.

Motion by Cole, seconded by Nolte to appoint Karen Auer- MS/HS 504 Coordinator, Amelia Vaughn-ES 504 Coordinator, Angela Anthony-Title IX Coordinator, Title VI Coordinator, and Age Discrimination. Motion carried 5-0.

Motion by Allen, seconded by Langworthy to approve the Career and Technology contract for the 2024-2025 school year. Motion carried 5-0.

Motion by Nolte, seconded by Allen to approve adding a softball tournament to the Oklahoma Union School Fundraiser list. Motion carried 5-0.

Mrs. Taylor went through the power point on the no cell phone survey results. Staff survey results were 47.5% no PEDS, parents 57% no PEDS in classroom, students 55.2% no PEDS in the classroom. Survey responses about benefits and concerns were also presented. No action was taken.

Motion by Allen, seconded by Langworthy to convene into executive session. Motion carried 5-0. Entered into executive session at 8:49 PM.

Motion by Cole, seconded by Allen to return to open session at 9:15 PM. Motion carried 5-0.

Motion by Langworthy, seconded by Cole to employ paraprofessionals Isabella Fuller and Kaley Smith on a support personnel contract for the 2024-2025 school year. Motion carried 5-0.

Motion by Langworthy, seconded by Allen to employ Dr. Angela Anthony for teacher certification support on an extra duty contract for the 2024-2025 school year. Motion carried 5-0.

Motion by Nolte, seconded by Langworthy to appoint Aaron Funkhouser-OK History/Civics and Chelsie Jackson-HS English as an Adjunct Teacher for the 2024-2025 school year. Motion carried 5-0.
