VRS Reporting Presentation

Effective in August, VRS for employees with contracts less than 12 months will be taken out over the contract period, rather than over 12 months.

VRS has been asking us to make this change for a few years. What this will do for our employees:

VI. BOARD COMMENT

Rick Mullins: The closer we get to opening the new elementary school I get more and more excited. I am really looking forward to that. I would like to reiterate the quality of the people that are working in our school system, administration, and teachers. They are just wonderful people and I am proud to be a part of it.

Dr. Lurton Lyle: I appreciate the Appalachian Service Project for their work in our county. I appreciate the United Way for the work in our schools.

Damon Rasnick: I can't help but sit here and reflect on all the work that's been done here. Let's start back 60 years and think about people in the office and what they had to work with. I had to reflect back to all the work that's gone into this by Mrs. Martin and Mrs. Edwards and Mr. Deel and all of the others. Mr. Mullins along with all of the other hats he wears he found another one. It strikes me with the kids and how we change and how we listen to people in authority and do the right thing. I know when I played football back in the sixties, your coaches wouldn't give you water. You would be out there in that sun and burning up. That was just a rule. In the Marine Corps if you got caught with two canteens full of water you would go to jail. The brig they called that. They would search for that from time to time. How far we have come and what we can do. The children how they were then. In Martin Town, all the boys just got off the bus and they'd all head up in the hollow, and people driving by thought this was crazy. There was a stock law back then. The milk cow was a pretty important item in the family. They would be with those cows. They would go hunting and bring them back to the yard and get milk. Then tie them down for the morning so you can milk them again. How far we have come and kids were about the same. I guess we were about the same in ways. Things changed around us and everything that I've ever done or anything I've been around even the twelve years I attended school here. You always have people that you could depend on every day to do the right thing as your parents and your teachers and maybe some others in the community. That were the ones you looked at and I think that is important today. The way we communicated back then was a lot of those kids walked to school up there on Long Ridge. They didn't have a bus. How far we have come. We have the means to communicate in such a way and if we make a slip up in public relations somehow, we are going to hear about it. We need to be right and I think our folks have done an excellent job. Going back and reviewing all these things and making them right. They will explain it to our parents in a good way for everybody to understand all this and everything that we do. It is still refreshing to know that most people are still good people. Most students are still good children. We tend to forget that. People are so negative and in trouble and seem to get a lot of attention. You are talking about a small fraction of the total number. Most kids are good. For those kids that are not if you look back far enough, you'll probably find a lot of good reasons why maybe some. If you and I were in that situation we might act out too. We need to be aware of that when we deal with them and treat them right. Be good to people. I am very proud of our staff for what they have done and for this Board for supporting those good things.

Jamie Hackney: I will just echo Dr. Lyle's comment. I am very appreciative tonight to have the United Way here and the Appalachian Services Project. All of the work that they do and the volunteers that they have in our county. The thing that they are doing for Dickenson County I am just appreciative of that. I also enjoyed the presentation tonight on solar panels. I am looking forward to seeing where that goes. I know we have questions that still need to be asked and answered on that but I am looking forward to seeing how that plays out.

Jason Hicks: I thought it was exactly what you guys said about seeing those projects and seeing those things happen at those homes. Those things are pretty exciting. It is great what others will do for others in this community. The trauma initiative, I think that is pretty exciting stuff. Especially if it's going to be a model for the rest of the state. That's very important. I think it has been lacking within schools in the last little bit. It's great that we're on that. I guess the biggest thing, I feel like we are just now being able to get really focused without distractions back on education and what we can do for our students. I am excited to see the leaps and bounds that come this following year as far as the education recovery that they are going to have. All of the academics and athletics and all the accomplishments they are going to have. I know they are probably still excited about a couple more weeks of being out. Maybe dreading that first day but once it gets going I think the focus and what we will be able to accomplish is going to be spectacular.
