# Reports

Board Reports: Dr. Stone reported that all student reports are prepared and ready for submission to the state. Stone and Sword attended the Title I conference held in Pierre. Michael Baker did a site visit to identify the various needs of the school and possible funding sources. Stone and Baker met with Senator Thune's staff and they were positive about possible sources to assist with the funding needs of the school. Dr. Stone informed the board that summer school was scheduled for June and many of the students have goals for credit recovery with the possibility to move to the next grade level with the work completed.

A motion by Tlustos, seconded by Quivey to approve Associated School Boards Worker's Compensation and Property and Liability Renewal.

## **Board Election**

The board approved the canvassing of the 1 year term results of the June 4<sup>th</sup> School Board election with the following: Vincent Logue, 47 votes, and T'mara Twiss, 9 votes. Oelrichs School District had 273 registered voters on the date of voter registration closure; a total of 56 registered voters or 21% voted in the election. Jennifer Her Many Horses was nominated and having no opposition at the School Board Elections was declared elected to the School Board of Oelrichs School District for a term of 3 years.
