Principal Determan reported that schedules for the next school year are almost completed. The state track and golf meets were held. The athletes did a great job at both of the events. At state golf, the boys team finished in 6th place.

Superintendent Anderson stated there potentially will be a special board meeting on June 30th at noon to finalize the fiscal year. Anderson has been in contact with the students who are taking a credit recovery class to see how they are coming along with them. A meeting with the return to learn committee will take place sometime before the July board meeting. The plan is to start the school year as normal. At the annual board meeting next month, a change in the handbook pertaining to eligibility for activities will be made. Eligibility will be checked at midterms and at the end of the quarter compared to just at the end of the semester. Currently the school rents the equipment used for Gregory Gorillas Live. The school will look to purchase the equipment. By owning the equipment, the share of the revenue the school receives will be greater. The school did receive the homeland security grant. There are still no updates pertaining to the repairs to the school. C&E Construction and EMC Insurance company are still going back and forth on their discussions. In the first 20 days of the summer lunch program, over 2,000 lunches have been served, with an average of 102 lunches per day.

Karen Timanus reported on CORE that they had a regular meeting. Cole Nicholas, who started a tech support business presented his business to the board. Contracts were issued to the Dial Virtual School teachers.
