

Mr. Lindeman and Ms. Muckian Lesson Plans March 30-April 3

You can get to Teams by signing into your school email account and then in the upper left corner there is a menu of 9 dots next to Outlook. If you hover your cursor over the dots it will say “app launcher” and then when you click on it you will see Teams as one of the apps so just click on that. You should see the Teams (classes) that teachers have signed you up for, if not, click on Teams in the toolbar to the left and you will see the Teams you are a part of. Just click on the Team (class) you need and look for the notes and assignments we have sent to you.

APUSH – We will be working through some readings and information about the Cold War and then beginning Civil Rights. I am purposefully saying that these need to be done at your convenience during the week rather than saying specific assignments for specific days. But everything is due by the end of the week or as noted on the assignment in Teams.

For Monday, please either send me the Word documents that you created to complete the reading and questions in the text and AMSCO book OR send me scans/pictures of the pages from your notebooks. If you are having problems figuring out the best way to do this email me and I can help.

You should have already seen the videos on the end of WWII and the beginning of the Cold War, those assignments were posted last week. You will see a reading on the Cold War and a written response to that reading, some practice SAQs, and also a quiz posted in the AP Classroom. The specific resources and assignments will be posted and turned in on the Microsoft Teams page.

Holocaust – the genocide projects are due by Wednesday morning. There will then be readings on the Nuremberg Laws, the Hitler Youth, Kristallnacht, and the Voyage of the St. Louis to complete the week. Our

goal is to begin the war next week and explore the expansion of the camps from “*concentration camps*” to “*death camps*” and how the Nazi’s subverted the system to make genocide possible.

AP Psychology – You were asked to complete the readings and reading worksheets for the psychopathology unit and the therapy unit. Please send me the Word document that you used to do all of that work OR scan/take-a-picture of the work in your notebook and send that to me through email by **Tuesday**.

There will be a couple more videos posted that you will need to view and some work for you to complete associated with completing our work on psychopathologies. By midweek we should transition to the modules on therapy that were handed out before we left and there will be some videos to support that work. There will also be some assignments in AP Classroom to assess your understanding of the material that you will need to complete. Everything will be posted in Microsoft Teams along with due dates.

Recent American History –

Monday: The Civil Rights Project is due. This includes the Power Point and Two page essay. You should email the PowerPoint and your essay to Ms. Muckian at smuckian@rsd.k12.pa.us.

We will be begin a unit on The Vietnam War for the rest of the week.

Monday-Tuesday - Students will complete a Vietnam Timeline. A brief power point and directions for the timeline will be posted in Teams. The timeline will be due Tuesday, at midnight.

Wednesday - Students will study containment and domino theories. A brief power point presentation and a primary source reading and question worksheet will be posted in Teams. The worksheet will be due Thursday.

Thursday - Students will learn about the Vietnam draft. A brief power point presentation will be posted, students will complete a song and video activity

that will also be posted in Teams. The Activity worksheet will be due Friday.

Friday - Students will learn about experiences the soldiers had at Vietnam. A brief power point presentation and a historical image analysis worksheet will be posted. The worksheet will be due Monday.
