

# Lowell Collaborative Preschool Academy is Now Enrolling for September 2018!

Lowell Collaborative Preschool Academy is supported by a grant from the U.S. Department of Education

Lowell Public Schools, Community Teamwork, and Little Sprouts have a PreK program called the <u>Lowell</u> <u>Collaborative Preschool Academy</u> located at 554 Pawtucket Street in Lowell. This preschool program has limited seats available and is open to children living in Lowell that are at or below 200% of the Federal Poverty Guidelines and have not had an opportunity to attend any preschool program/family child care in the past.

## Who is eligible for this FREE, full-day, full-year program?

If you have a child who is:

- A resident of Lowell and will be 4 years old by September 1, 2018 (born between September 2, 2014 and September 1, 2013)
- Not currently attending a preschool/center based program, family childcare or Early Head Start/Head Start program or attended one in the past
- Meets the income eligibility (refer to chart on back for guidelines). You must accurately complete the Household Economic Data Survey
