Andrea Johnson opened the meeting. Hayley Wiseman seconded it.

President Allyson Jones reviewed the updates regarding safety and security per the agenda.

Discussion of the shade for the main entrance/office area for Leah is still pending.

Discussion of the dead bolt on the door at Leah's desk is still needed. There is a need for the dead bolt on the inside to be able to be locked. As of now it can only be locked from the hallway side with a key.

Haley Wiseman: Discussion of the door by the teachers' mailboxes that connects the office to the hallway is needing to have an inside key pad to prevent an intruder from being able to easily enter the hallway, if the situation would arise. Maria will look into the keypad being installed on the inside of the office.

President Allyson Jones had VP Savannah Silber review the update on student discipline.

Grade Breakdown: 20 from Kindergarten, 14 from 1st, 36 from 2nd, 9 from 3rd, and 10 from 4th.

Assistant Superintendent has stated the behavior needs to be a Level 3 or 4 to qualify for an out of school suspension. Level 1 or 2 behavior violation would include time out, in school suspension, lunch detention, loss of activities, or contact of parent. When an OSS is issued for a Level 1 or 2 Behavioral Violation this negatively impacts the school's scorecard. Andrea Johnson questioned Level 1 and 2 behaviors with habitual students. Mrs. Clendenin clarified that once a student obtains 10 referrals for the same infraction, further discipline and actions can be taken.

92% met the SOAR Celebration goal

2nd Nine Weeks will be a SOAR Celebration with hands on science kits.

President Allyson Jones discussed that Flinn has a 94% attendance rate, 16% are chronically absent. The goal is to stay under 20%, which Flinn is achieving this goal.

President Allyson Jones shared the updates regarding curriculum. The teachers are still learning the new program, Math and You. Teachers are required to do an assessment check on students who are falling far below mastery every 10 days, and every 15 days for kids who are slightly below. Monthly meetings are held to monitor that data, to ensure progress is being made. January marks the mid-year benchmark time for reading (DIBELS and iReady) and math (iReady). Our 3rd and 4th grade students participate in an additional mid-year benchmark as they prepare for the end-of-year state test (WVGSA).

President Allyson Jones shared the updates regarding Social & Emotional Learning and Wellness. The school has a monthly SEL focus and this month's is Self-Care and Stress Management.

She continued to explain that our current parent involvement has been focused around Santa's Workshop and will soon be on Valentine's Day parties.

Sandra Lilly delivered 2 boxes of gift bags for the Santa's Workshop. (Thank you, Sandra!)
