Two physical fights, and one threat against a school employee. Most reports are due to disruptive, disrespectful, disorderly behavior. Mr. Davis made parent phone calls, and had parent conferences regarding behavior. Midland Trail Elementary is now using DOJO. Teachers can relay important messages/data about behavior to parents.
