I. Call to Order and Approval of Agenda

The Rock Hill School District Three Board of Trustees met this date at 6:00 p.m. with members present as follows: *James Burns, Windy Cole, Mildred Douglas, Brent Faulkenberry, Helena Miller,* and *Robin Owens* and *Superintendent Dr. Bill Cook. Patrice Cherry was absent.*

VIII. Report of the Superintendent

A. Announcements

Superintendent Cook made the following announcements:

• With 1,480 employees now fully vaccinated, our two-week trend data for staff has dropped to its lowest levels this school year. Two-week trend student data, which peaked in January following winter break with 1,121 dashboard entries, has been on a rapid decline and reached levels similar to October early last month. However, our most recent data shows the trendline beginning to move in the wrong direction for our students. We believe the continued use of masks/face coverings and social distancing to the extent possible are two

- of the most effective mitigating strategies we can continue to implement in our schools to ensure we do not continue to see data inch upward.
- Rock Hill Schools continues to offer rapid COVID-19 testing to students and staff. We continue to believe this mitigation strategy continues to be an effective tool for our school nurses to identify students and staff who are affected. The testing helps to isolate individuals more quickly and prevent on-campus spread. As of last week, our nurses have administered more than 530 BinaxNOW rapid tests for students and staff.
- The School board will next meet on Monday, April 26. The meeting will be broadcast on our website and will be available for viewing on-demand immediately following each broadcast. We invite our community to watch meetings live on our Facebook broadcasts at Facebook.com/RockHillSchools.
