Students with Season Passes: If you do not require lessons – you can pay for transportation. (**Note, if bus is full, students that sign up through Jiminy Peak have preference**) If you require lesson, you will have to make arrangements directly with Jiminy Peak.

Bus transportation is based on the number of participants- After all students have registered we will Notify you with transportation fee.

Participants: **Only Grades 5 - 12 students will be able to participate in ski club.** CES students will be picked up around 2:40pm by the same motor coach bus that picks up the MS participants. All of Grade 5 gear should be with them at CES. They will return to the High School at the end of the ski trip.

Departure Time: JR/HS bus will leave at 2:30pm
CES at 2:45pm.

RETURN TIME: All buses will return to the HS around 9:15pm

POLICY ON PICKING UP STUDENTS AT JIMINY PEAK:

- Only parents may pick up their own children at Jiminy Peak. Students will not be released to older siblings or any other relative, nor will they be released to parents of other students.
- If a parent intends to pick up a skier at Jiminy Peak, a note is to be sent in with the student advising the Ski Club chaperones of this intention.
- The parent must speak directly to a Ski Club Coordinator with their child at 8:30pm in the lodge at Jiminy Peak before a skier will be permitted to go home with the parent. If a parent does not speak to the Coordinator, the student will be expected on the bus even if a note is in the chaperone's possession. This rule exists so that the

chaperones can be sure the parents have arrived safely and that your child will not be left unattended. The bus will not leave if we cannot account for all skiers. Please be prepared to show photo ID.

WEATHER CANCELLATIONS:

If a Ski Club date is cancelled, the Ski Club Coordinator and Jiminy Peak will select a make-up date depending on weather. It is possible that a mid-week date might need to be selected. The 7th trip to the Jiminy Peak is considered optional by Jiminy Peak. If weather conditions force the cancelation of the optional date, all efforts will be made by Jiminy Peak and ski club to reschedule.

EMERGENCY PROCEDURES AND PHONE NUMBERS:

If your child is injured, you will be notified as soon as possible by telephone by the Ski Club Coordinators. The Jiminy Peak Ski Patrol will assess and make recommendations based on the condition of the skier. Your child may be sent by ambulance to a local hospital; the closest being Berkshire Medical Center. (413-447-2000).

It is essential in a medical emergency to be able to speak with a parent to authorize medical care. It is the skier's responsibility to keep the emergency phone list up-to-date.

SKI CLUB RULES

1. **Please review the attached information about attire, equipment and behavior provided by Jiminy Peak.**
2. **All Ski Club participants must wear helmets.** This is to protect your child from injury. There will be no exceptions from this rule and any student that does not comply will not be allowed to participate.
3. Each person who signs up for the program will receive one season ski pass that is good for all of the Friday nights that we attend. It may only be used on the nights that we are attending. Tickets are not transferable and may not be sold or traded. They must bring this ticket with them each week.
4. **There is a \$25.00 charge to replace lost ski school passes. There is a \$20.00 fee for a temporary pass.**
5. All skiers are expected to attend their weekly lessons. This policy is necessary not only for the improvement of each skier's ability, but also for the safety of all skiers on the mountain. Skiers that do not attend lessons will lose their ski pass for the remainder of the evening. Repeat offenders will not be allowed to participate in ski club.
6. If your child would like to use the Coyote Ridge Terrain Park, they must watch a safety video and then purchase the Coyote Ridge Park Pass from Jiminy Peak. This process is arranged and completed by Jiminy Peak.
7. Ski Club will be cancelled if school is cancelled due to inclement weather.
8. If your child is absent from school or arrives at school after 8:30 without a legal excuse, they will not be eligible to participate in Ski Club that day.
9. Please discuss "**caution**" with your child. Urge him or her to follow ski instructors' suggestions as to where to ski and how fast to go. Jiminy Peak will deny skiing privileges to skiers who endanger others by skiing recklessly.
10. Each person who signs up for the program will receive one season ski pass that is good for all of the Friday nights that we attend. It may only be used on the nights that we are attending. Tickets are not transferable and may not be sold or traded. They must bring this ticket with them each week.
11. Skiers must understand that their behavior and activities while on the bus and while at the ski resort are a reflection not only upon themselves but also upon the entire group. Misbehavior by individuals can jeopardize the skiing privilege of the entire group. A member may be removed from the club upon the recommendation of the Jiminy staff, ski patrol, the Maple Hill Ski Director and/or the Building Principal. If a member is removed for disciplinary, behavioral, or health reason, **NO** refund of money is possible due to contractual arrangements.

with the bus company and Jiminy Peak. Please ask your child to read carefully the attached rules from the ski area.

12. Other school rules, policies, legalities and common sense rules of behavior and conduct apply to all ski trips. Students who become **ineligible** for extracurricular activities may not participate in ski club.
13. **Students must ride the ski bus to Jiminy Peak.** If you plan to visit Jiminy to see your child ski and would like to drive your child home, please see the advisor that night. **Parents are the only people that we will release a student to.** Be prepared to show identification. Otherwise, students must return on the ski bus.
14. Please encourage your child to use a ski lock. Theft is common.
It is Jiminy Peak's policy not to issue a refund once a student has enrolled and paid the fee. Ski Club does not have the ability to refund money for Jiminy Peak. A credit may be issued for certain conditions with the appropriate documentation.
15. **If your child has a medical condition that requires medication, they must be able to self-carry/administer their medications. A Doctor's note of approval is required.**

SUMMARY OF THE CODES OF CONDUCT FOR STUDENT PARTICIPATION IN EXTRA-CURRICULAR ACTIVITY

STUDENTS AT SCHOOL SPONSORED OFF CAMPUS EVENTS SHALL BE SUBJECT TO ALL RULES AND REGULATIONS OF THE SCHOOL.

The purpose of this document is to establish a clear understanding of the expectations for and responsibilities of the student involved in the Ski Club program. It is hoped that the standards described and the community's willingness to meet these standards will help to establish a life-long pattern of healthy and responsible behavior in our students.

Participation in Maple Hill extra-curricular activities is a privilege that brings with it a requirement of commitment as well as added responsibilities on the part of the student.

Student Responsibilities: Student responsibilities include: demonstrating respect for and kindness to others; working to achieve their full potential; following school rules and the directions of school staff, faculty and administration; fulfilling all educational assignments and obligations; demonstrating respect for school property and for the property of others; modeling good conduct; presenting themselves neatly in clothing that is safe and suitable for school activities and will not disrupt the education process; financial responsibility for books, tools, computers, locks or any other school property or equipment provided to them.

Prohibited Behavior: The behavior prohibited by the student code of conduct includes: disorderly and disruptive conduct; insubordination; truancy; violent or threatening behavior; possession or use of alcohol or illegal drugs; possession or use of a weapon; destruction of property; harassment of any kind including bullying of other students; use of any tobacco products; misconduct on school busses; reckless driving; academic misconduct (cheating or plagiarism).

Academics: A student must be in good academic standing in order to be eligible for full participation in extra-curricular activities. Students in grades 7–12 who are in jeopardy of failing two courses as indicated on the interim report or who failed two courses as indicated on the quarterly report card: may continue to participate with a team or continue to attend meetings of a club or activity if the student accepts a remedial plan of weekly supervised study. At the end of five weeks, students in grades 9–12 who continue to fail two courses will be removed from participation in any sport or activity until the next report either interim or quarterly report card. Once declared ineligible, a student in grades 9–12 remains ineligible until he/she is no longer failing or in jeopardy of failing two courses.

At the end of five weeks, the progress of a student in grades 7–8 will be reviewed weekly until he/she has achieved a passing grade. Students who do not accept or follow the remedial plan may not participate in Ski Club until the next report.

Use of Tobacco, Alcohol or Drugs

The use of tobacco, alcohol or drugs is strictly forbidden.

- Any student who uses tobacco products, alcohol or controlled substances in any form other than those prescribed by a physician for his or her own use will be removed from all clubs/activities for the remainder of that season, duration of activity or 30 consecutive school days, whichever is longer. If this behavior takes place in school or at any school related activity, the student will be subject to all other penalties which apply in addition to the removal from the activity.
- A coach, faculty or staff member, administrator or Board of Education member has a responsibility to report a student observed violating this rule at any time.
- Parents also have a responsibility to notify the coach or advisor when they are aware that their child has violated this rule.
- Any student who violates this rule has a responsibility to remove himself/herself from participation on a team or in an activity.
- If a student finds himself/herself in a situation where tobacco, alcohol or controlled substances are being illegally used, he/she must immediately remove himself/herself from that situation. A student's failure to do so will result in a meeting between the student, coach and athletic director or student, advisor and principal to determine whether or not any disciplinary action is warranted.
- Students may reduce up to 50% the length of duration of any penalty by participating in a counseling, assessment or cessation program recommended by the athletic director or principal (whichever is appropriate) and approved by the superintendent. The decision may be appealed to the Board of Education.
- For a second offense of using tobacco products, alcohol, or controlled substances the student will be removed from all athletic programs or clubs/activities for twelve months from that date.

Conduct

Participation in extra-curricular activities requires strict adherence to school and community rules. Students who violate such rules will be subject to penalties ranging from a warning to removal from all extracurricular activities.

- A student who receives at least one day of in-school suspension will not be allowed to participate in any extra-curricular activities for that day.
- A student who receives out-of-school suspension will not be allowed to participate in any extra-curricular activities for the duration of the suspension.
- A student in grades 7-12 who accumulates ten discipline referrals or five days of in-school and/or out-of-school suspension during the same school year must meet with the faculty coordinator and/or athletic coach and parents or guardians, principal and, when applicable, the athletic director. The purpose of this meeting will be to gather information about the conduct for a decision regarding the student's eligibility to participate in extra-curricular activity for the remainder of the school year. The principal will make the decision regarding the student's eligibility. The decision of the principal may be appealed by the student to the superintendent of schools and, subsequently, to the Board of Education.
- A student who has been arrested by any local, county and/or state law enforcement agency must meet with the faculty coordinator and/or athletic coach, parents or guardians, principal and, when applicable, the athletic director. The purpose of this meeting will be to gather information about the relationship of the alleged conduct to the intent of this policy for a decision regarding the student's eligibility to participate in extra-curricular activity. The principal will render a decision regarding the student's eligibility. The decision of the principal may be appealed to the superintendent of schools and, subsequently, to the Board of Education.

I further understand that it is impossible to foresee all the possible injuries that a participant may suffer as a participant in the above sport/activity and I understand the above listing is merely an illustration of some of the injuries which I could suffer by participating in the above sport/activity. I also understand that the dangers and risks of participating in the above sport/activity may result not only in serious injury but in a serious impairment of my future ability to earn a living, to engage in other business, social and recreational activities and generally enjoy life.

I understand that this warning is intended to notify me that by participating in the above sport/activity, I will be engaging in an activity which has inherent risks of injury. I am asking to participate in the above sport/activity with the full knowledge of the risks involved.

WAIVER

In consideration of the Schodack Central School District permitting me to participate in the Ski Club and engage in all activities related to this sport/activity, including transportation to and from the activity, and intending to be legally bound, I do hereby assume all risks associated with such participation and do agree to release and forever discharge any and all rights and claims for damages, including claims for loss, damages or injury to my person or property arising out of the performance or failure of the performance of the Schodack Central School District or the respective officers, its employees, agents, representatives, successors and/or assigns of the Schodack Central School District, for any and all damages which may be sustained and suffered by me in connection or association with my participation in any activities related to the Schodack Central School District Ski Club Program.

These terms shall serve as a release and assumption of risks for my heirs, estate, executor, administrator, assignees and for all members of my family.
