Bills for Approval

The Board approved bills for the period February 21, 2019, through March 13, 2019, listing checks which totaled \$2,790,165.09.

Memorandum of Understanding - AFSCME Four-Day Work Week

The Board approved the Memorandum of Understanding with District Council 89 of the American Federation of State, County, and Municipal Employees, AFL-CIO for a four-day work week during the summer of 2019.

Capital Area Intermediate Unit 2019-2020 General Operating Budget

The 24 school districts of the Capital Area Intermediate Unit (CAIU) contribute towards its general operating budget. The Board approved the CAIU's proposed 2019-2020 General Operating Budget totalling \$6,390,000.00. For 2019-2020, West Shore will contribute \$90,986.24. This represents a \$2,096.54 decrease from the 2018-2019 budgeted allocation.

Amendment to Articles of Agreement for Cumberland Perry Area Vocational Technical School

The Cumberland Perry Area Vocational Technical School is interested in changing the school's name to Cumberland Perry Area Career and Technical Center.

In order to become effective, this change must be ratified by the member school districts through a change to the articles of agreement. The Board supported the change by adopting a resolution in favor of amending the articles of agreement.

Board Policies

The Board approved revised Board Policies 108: Adoption of Textbooks, 127: Assessment System, 704: Maintenance, 810: Transportation, and 818: Contracted Services as well as New Board Policies 317.2: Educator Misconduct, 810.2: School Bus Drivers and School Commercial Motor Vehicle Drivers, and 810.3: School Vehicle Drivers.

The Board repealed Board Policy 351.1: Controlled Substance/Alcohol Requirements for Covered Personnel.

Student Trip

The Board approved a trip for the Cedar Cliff High School JROTC to compete in the First Annual JROTC Joint Services Invitational Fitness Challenge in Fort Story, Virginia from May 9-12, 2019.

Staff Attendance at Professional Meetings

The Board approved the requests for staff attendance at professional meetings as presented.

Resolution Supporting Senate Bill 34 and House Bill 526 for School Districts Providing Their Own Cyber Learning Program

The current funding formula for cyber charter schools is based on school district expenditures with no relationship to the actual instructional costs for regular and special education students attending the charter school. As a result, since 2009-2010, funding of cyber charter schools has cost school districts and their taxpayers a substantial amount of money.

The Board adopted a resolution calling for reform of funding for cyber charter schools. The resolution is [posted on the District website](#) and will be submitted to all elected state representatives and senators serving the District in the Pennsylvania General Assembly, and to the Governor of Pennsylvania.
