- 1. Board approved the consent agenda, which included the minutes of the February 19th Regular Meeting, warrant report, payment of bills, treasurer's report and petty cash report. Also heard administrative reports.
- 2. Under Old Business
 - a. Board heard an update on the upcoming \$1,950,000 General Obligation Bond Issue that will be on the April 2nd General Election Ballot.
- 3. Under New Business
 - a. Board authorized the superintendent to enter into an agreement with McKinstry based on the passage of the bond issue.
 - b. Board approved the health insurance renewal for 2024-2025 with MEUHP. The district will offer five health insurance plans for employees and contribute \$650/month toward premiums.
 - c. Board reviewed the application received for the vacant position on the board of education and appointed Callie LaBeth to the board.
- 4. The board held an executive session, taking the following action:
 - a. Approved Josephine Fayard as an addition to the substitute teacher list.
 - b. Approved staff members who completed year 2 of LETRS training to receive a \$500 grant funded stipend.
 - c. Accepted the resignation of Nicole King, elementary teacher, effective at the end of the 2023-2024 school year.
 - d. Renewed contracts for all certified teachers.
 - e. Approved a recommendation to hire Gary Griffin as a part-time high school science teacher for the 2024-2025 school year.
