

**Minutes of the Board of Education of the

Call to Order

Motion by Her Many Horses, seconded by Tlustos, to approve April 16, 2019 meeting minutes.

Motion by Tlustos, seconded by Her Many Horses, to approve the amended agenda; adding 6.1 Election Board.

Reports

Board Reports: Dr. Stone gave an update on the current situation with the water waste system and plans for future updates. The REAP and Indian Education grants have been submitted and approved for next fiscal year. Graduation was a success with two students speaking for the class. Michael Baker will be visiting the school next month to share information about sustainable communities. Principal Castro informed the board that all of the testing and the Civil Rights Report are completed for the school year. One student has been accepted into Job Corps.

A motion by Logue, seconded by Her Many Horses to accept the resignations from Tara Schuhmacher, Tamera Hughson, and Lee Linehan.

Election Board

Motion by Her Many Horses, seconded by Tlustos to appoint Elizabeth Little and Diane Wesby as precinct deputies and Anita Cope as precinct superintendent. The election board will be compensated at

a rate of \$120 for the day of the school board election, to be held at the school, on June 4, 2019. Logue abstained from the vote.

Motion by Her Many Horses, seconded by Tlustos to accept the continuing coaches' contracts based on the recommendations from Katie Bauder, Activities Director.

Contracts

Kirchgasler and Gorsuch presented a plan to restructure the Special Education Department for the 2019-2020 school year. Motion by Tlustos, seconded by Logue to approve a contract for Connie Gorsuch to be the Special Education Director/Teacher at a salary of \$65,000 for the 2019-2020 school year.

Motion by Her Many Horses, seconded by Tlustos to recycle the technology surplus list provided by Deana Castro.

Motion by Quivey, seconded by Logue to approve the presented 2019-2020 school calendar.
