# Update on the FY25 Budget

### V. Superintendent Robinson

Laura Taylor and Lacie Edwards, Director of Business and Finance, will present the Update on the FY25 Budget.

On Monday, May 13, 2024, Governor Youngkin signed the state budget. Please take a look at the attached document. This is our projection based on the Governor's Budget including the updated amounts of expected State Funding, Required Local Match (RLM), and additional Local Funds.

#### The decrease of \$163,070,00 in State Funds is due to:

- a. Decrease ADM or student enrollment to 1735 due to projected PK and K student enrollment numbers for 2024 2025.
- b. Decrease in Sales Tax
- c. Increase in per per-pupil allocations
- \$35,450.00 decrease in Required Local Match (RLM) is due to the reduction of State Funds.
- \$200,000.00 decrease is the proposed reduction in local appropriations from the \$500,000.00 requested. This is <u>unofficial</u> until the Board of Supervisors takes action on their budget.

### How does this impact DCPS?

- We are facing a budget deficit of \$398,520,00 from the budget approved on March 27, 2024.
- All employees will receive a 3% + step increase as approved in the State Budget.
- At this time, the proposed 5% salary increase to teachers and the 4% salary increase to custodians and cafeteria staff.is not in the budget.

# Transition of CES to Ridgeview Campus for the 2024 - 2025 School Year

 Update on Transition of CES to Ridgeview Campus for the 2024 - 2025 School Year

### (This is an informational/discussion agenda item for the School Board)

- Detailed Discussion with walkthroughs and identification of learning spaces for the Transition of CES to the Ridgeview Campus and 5th grade to RMS has taken place between administrators directors, and maintenance staff as to to the availability for 5th and 8th grade students at RMS and RHS.
- Required renovations to classrooms will begin in March at RMS to accommodate 5th grade.
- Furniture for additional RES and 5th Grade Classrooms at RMS classrooms will be finalized and ordered in late February.
- Technology equipment needs for the transition has been addressed.
- Staff placement process has taken place: Input from RES, RMS and CES administration took place on Mar. 21, 2024 and we are requesting School Board approval on March 27, 2024.
- Arrangements have been made with moving companies to accommodate the staff transition from CES to RES, and RES to RMS.
- Thorough cleaning has begun at CES of materials and packing boxes will be delivered to CES at end of May. Moving of boxes will take place in June/July.
- Future planning and preparation is a year to year process for proposed grade level placement at RMS and RHS which is to determined by student enrollment and available classroom spaces at RMS and RHS
- Based on current PK and Kindergarten registrations and current student enrollment, the 2024 2025 projected student enrollment and proposed grade configuration options are:
- RES: 642 students: PK -4th Grades
- RMS: 574 students:5th 8th Grades
- RHS: 575 students: 9th 12th Grades
