Revised Dress Code 2014-2015

Mr. Kraftson has spent the year gathering information about the uniform policy and observing how it operates within our school. Based on conversations with the administrative team and observations throughout the year, he feels we should make some revisions. Proposed revisions and discussions of those revisions include:

- Manufacturer's logos may be visible but should be no larger than the size of a standard business card (3 ½ in. x 2 in.)
- Re-allowing spirit wear to be worn throughout the week, not only on Fridays.
- Removing the "button rule".
- Adding navy blue to approved colors for polos.
- Adding navy blue to approved colors for polos.
- Adding corduroy pants to approved pants.
- Removing the requirement to tuck in shirts.
- Removing the belt requirement.
- Allowing students to have open-toed shoes.
- Changes to the P.E. Uniform.

After discussion Ms. Tyson moved to approve changes to the Uniform Policy with the exception of adding the tucking in the shirts rule and the closed toe shoes rule back in. Ms. Bortney seconded. Motion passed.
