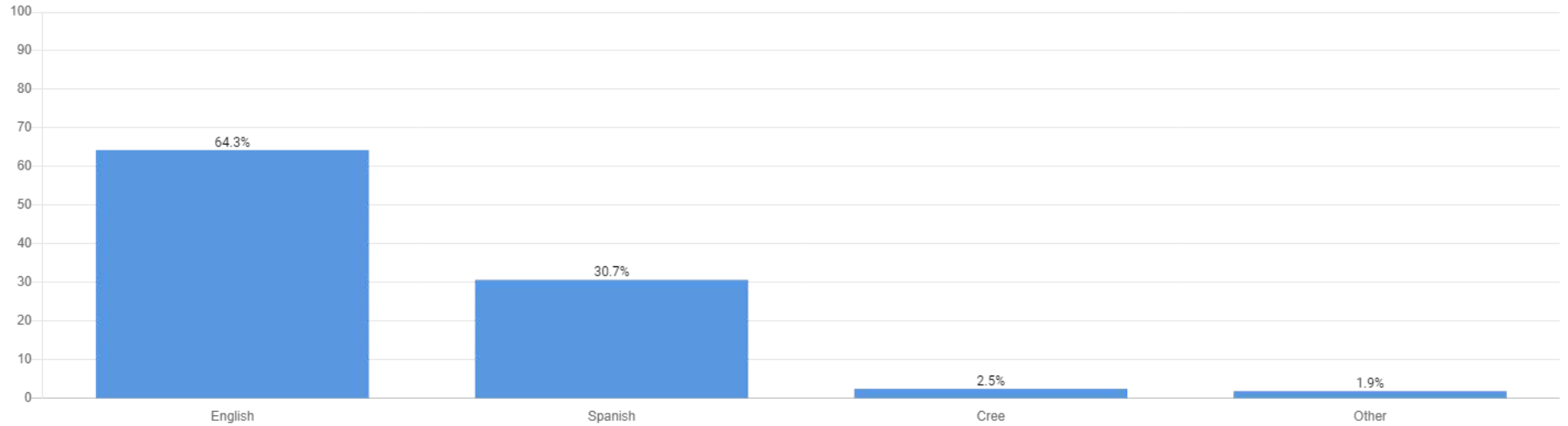

## Student Growth

Student growth is a measure of how much students are learning each year. New Jersey's ESSA state plan outlines that academic progress will be measured with school's median student growth percentile (mSGP) on statewide ELA and mathematics assessments. Each individual student receives a Student Growth Percentile (SGP) for English Language Arts (ELA) in grades 4 through 8 and for Mathematics in grades 4 through 7. The SGP measures their academic progress from one year to the next compared to other students with similar prior test scores (academic peers).

A student's SGP falls between 1 and 99 and can be grouped into three levels. An mSGP below 35 indicates low growth, an mSGP between 35 and 65 indicates typical growth, and an mSGP greater than 65 indicates high growth. If the SGPs for all students are ordered from smallest to largest, the mSGP is the percentile in the middle of the list.

**Important Note for 2022-23:** Student growth data is not available for the 2019-2020, 2020-2021, and 2021-2022 school years due to federal waivers and assessment cancellations. An alternate measure of academic progress, or growth, called Relative School Improvement Measure (RSIM) was used for the 2021-2022 school year only.

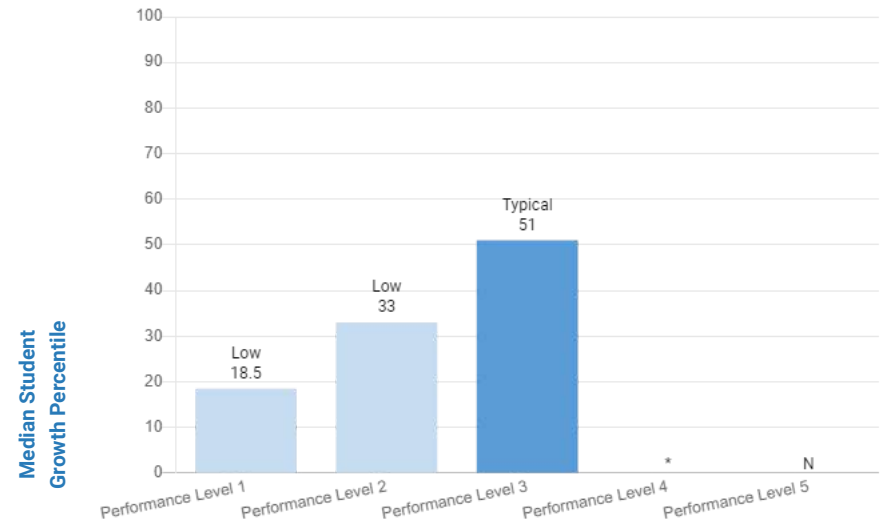
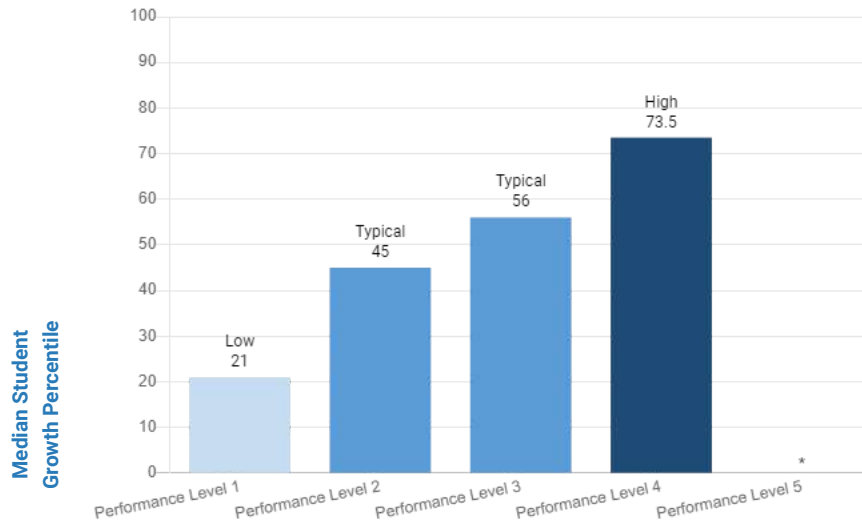

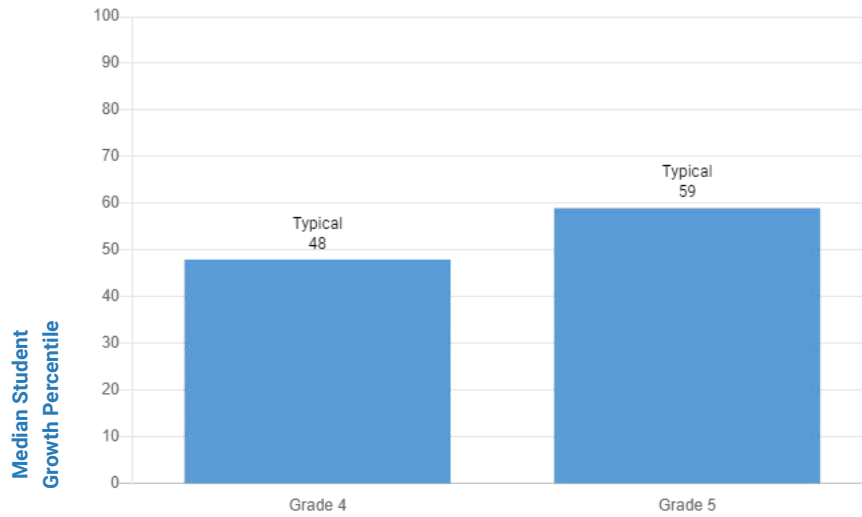

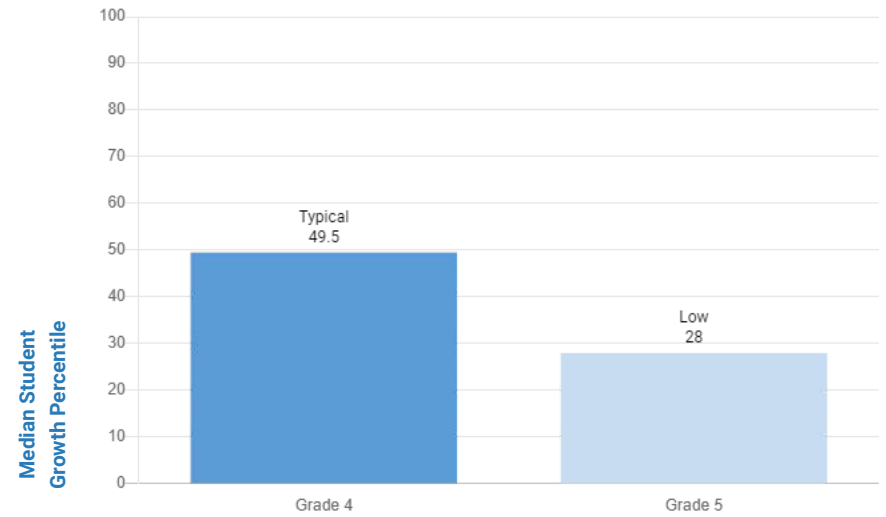

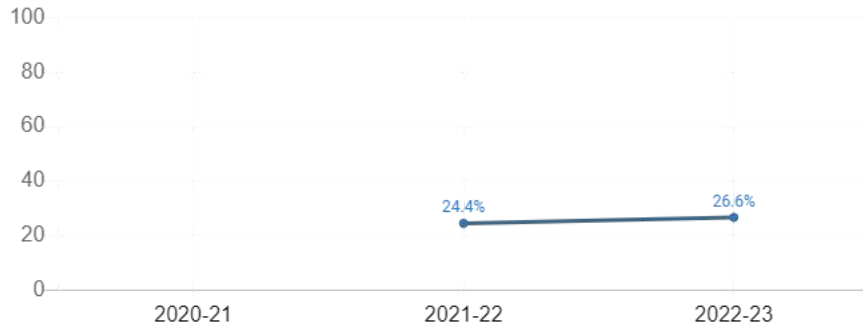

### English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. Students who were enrolled for less than half a school year are excluded from performance results. The table below provides participation rates, proficiency rates, annual targets and status in meeting the targets, and statewide proficiency rates.

Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM.

This table shows both the percentage of students who met or exceeded expectations and a proficiency rate used for federal accountability. The proficiency rate for federal accountability will be lower if the participation rate is below 95%. This table also shows progress towards meeting the state's long-term goal of 80% proficiency by 2032. Annual targets are specific to each subgroup, school, and district and represent the expected proficiency needed to stay on track to meet the state's long-term goal. 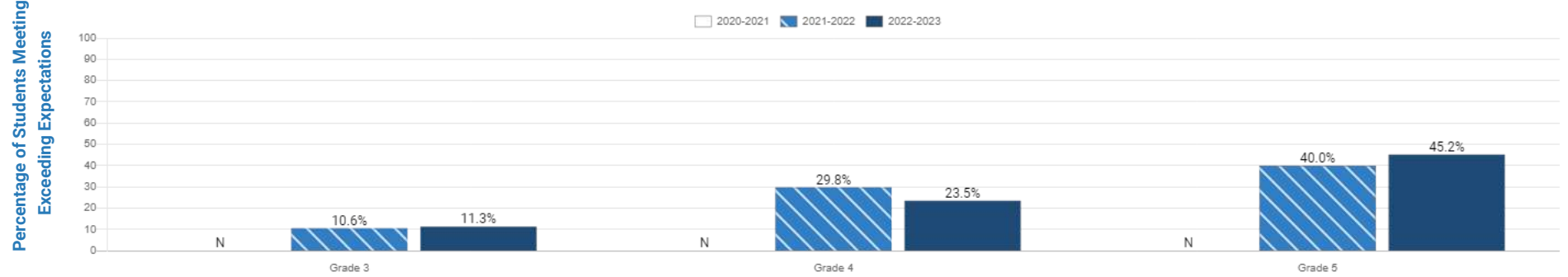

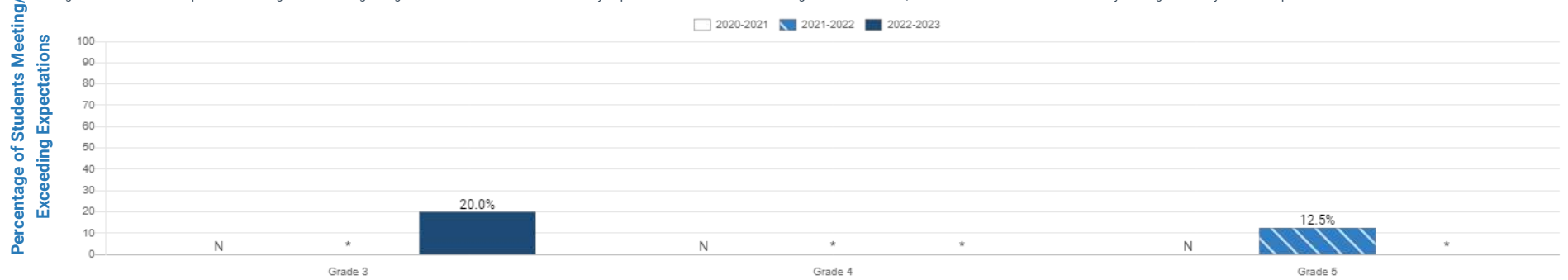

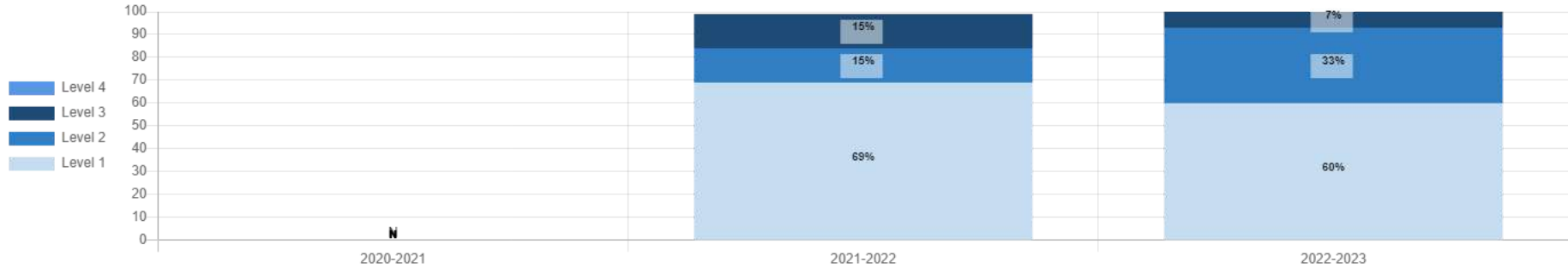

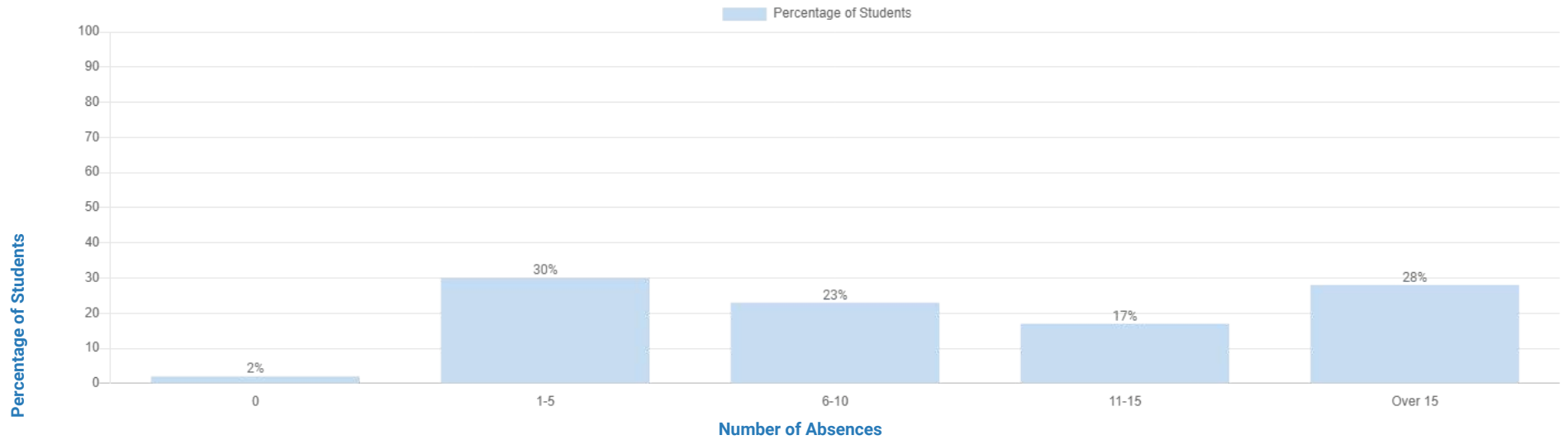

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.



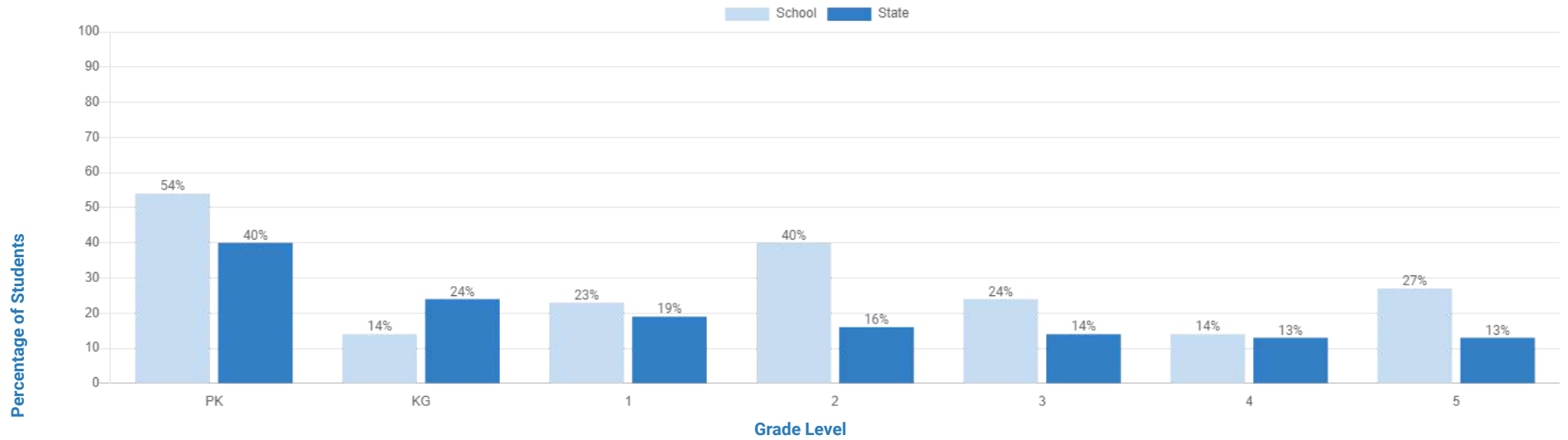

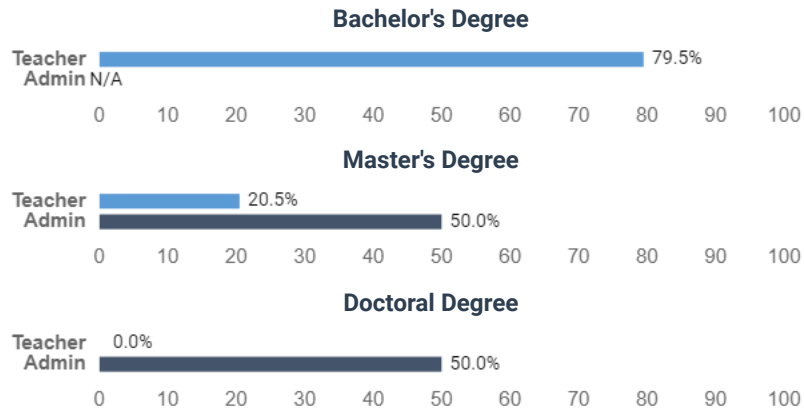

## Accountability

**New Jersey's Every Student Succeeds Act (ESSA) Accountability System** New Jersey's school accountability system identifies schools that are in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
  - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
  - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
  - All schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
  - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e., ATSI schools that do not meet exit criteria.
  - The fall 2023 identification is the first year that the NJDOE identified schools in this category.

Annually, NJDOE will identify schools in the following federal category:

- **Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):**
  - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

For purposes of ESSA accountability, only schools and student groups with data for 20 or more students are included in calculations.

**Important Note for 2022-23 Reports:** The NJDOE received approval to make a one-time change to the identification timeline under the [COVID-19 State Plan Addendum](#). Under the approved Addendum, the NJDOE identified schools for CSI and ATSI status in both fall 2022 and fall 2023. Schools that were identified for CSI or ATSI status in fall 2022 were eligible to exit status at the end of the 2023-2024 school year if all exit criteria were met. Schools that were identified for CSI or ATSI status in fall 2023 will be eligible to exit status at the end of the 2026-2027 school year if all exit criteria are met. Schools identified for TSI status are eligible to exit annually if exit criteria are met.

The NJDOE resumed using median student growth percentiles (mSGPs) to measure academic progress, or growth, for the 2022-2023 school year. The NJDOE had received approval through the Addendum to use an alternate measure of academic progress, Relative School Improvement Measure (RSIM) for the 2021-2022 school year only because mSGPs were unavailable.

## Accountability

### Highlights:

- MCES provides rigorous instruction in ELA, Math, STEM, and SEL. Tools of the Mind curriculum is used in our pre-K and kindergarten classes. One quarter of our students receive ESL instruction
- Kindergarten through 5th grade students have 1:1 Chromebooks. Students and teachers utilized Google Tools for Education. Our staff have access to SWIVL camera systems for lesson reflection.
- Strong focus on SEL for our students and staff. Numerous cultural activities were conducted for our students and families. Our ESL students utilize Imagine Learning to support language acquisition.

Our mission is: To provide a safe, welcoming, and culturally responsive environment designed to foster positive character qualities and academic rigor in education where every child can achieve their full potential.

Teachers continued to apply for and have received funding for class projects and equipment from DonorsChoose.Org. Students participated in academic and character achievement recognition programs.

### Courses, Curriculum, Instruction:

Tools of the Mind curriculum is used in our Pre-K and kindergarten classes. Readers and Writers Workshop Model is used in grades 1-5. DRA2 is utilized for assessing our students' reading levels. Everyday Math is used in our grades K-5 math classes. All students participated in our 1:1 Chromebook initiative. Visual and performing arts classes, as well as ESL classes are part of the daily curriculum. Standards based report cards are used in grades K-5. TCI is utilized for our science curriculum, and our students attend environmental science courses at SummerWood. Students participated in Water safety classes at our aquatic center. Sign Language is part of our World Language curriculum.



### Clubs and Activities:

Approximately 30 5th-grade students were members of our school's Safety Patrol. For the 2022-2023 school-year there were 35 4th and 5th grade students that participated in the our school's chorus, which performed for students and parents along with the Band students.

### Staff and Professional Learning:

Our teachers received Units of Study, Tools of the Mind, use of data collection tools and strategies, and Readers and Writers Workshop model training in the district ongoing throughout the year. Our annual district calendar provides seven full days of professional development. Teachers participated in weekly one-hour Professional Learning Community (PLC) sessions with their grade level partners. PLCs were facilitated each week, rotating among teachers, principal and supervisors. Additional training included trauma-informed and social emotional learning (SEL).



### Student Supports and Services:

We had 4 full time ESL teachers providing ESL, High Intensity educational services to our ESL student population. Students that test out of ESL are tracked within our school for two years. We provide ICS, Resource, and Self-Contained educational programs to our special needs population. I&RS is utilized to identify and provide services for regular education students that are referred by teachers, the school counselor, school nurse, and/or parents. We offer counseling services through the local YMCA. Our staff demonstrates compassion and cultural competence through daily interactions, joint recitation of our student and staff creeds and school wide events such as our Black History Month and Hispanic Heritage Month "virtual" celebration events, Respect Week activities, World Kindness Day observance, etc.



### Student Health and Wellness:

We have an active Breakfast program, which is offered to all students from 7:50-8:25 am daily. Our school counselor conducted character education instruction for all grades, including on-site counseling and screenings. Our school nurse provided health and family life instruction to students in grade 5 in conjunction with staff from CentraState Medical Center (virtual). Our 4th grade students were provided an assembly program from CentraState, titled Gateway to Trouble (virtual). Students participate in organized Gym class with the PE Teacher. In addition, all students participated in fun and engaging classroom teacher-directed PE activities. Student well being was monitored through the I&RS process. SEL instruction utilizing the Second Steps program was delivered weekly by the guidance counselor and classroom teachers.

### Parent and Community Involvement:

Our Parent Teacher Organization (PTO) is composed of parents from diverse backgrounds; teachers and staff from multiple grade levels/positions; and the principal. The PTO held monthly in-person meetings, featuring childcare and Spanish translation for parents, to inform about school and community happenings. The PTO sponsored and/or assisted with a broad array of educational and entertaining events for students throughout the year. These included student field trips- Planetarium and Pirate Adventure; Hispanic Heritage and Black History Month celebrations; author visits and literacy events. Parent-teacher conferences were held afternoons and evenings in the fall and spring over ten days. Communication to parents occurs in English, Creole and Spanish via teacher notices; PTO notices; school Website; Twitter; and School Messenger voice, text and e-mail communication service.



### Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Teachers. Each year we utilize the New Jersey School Climate Survey to determine how our parents, students, and staff feel about the school climate. Post Staff Climate Surveys indicated: 58% felt the school has a sense of vision, and a mission that is shared by all staff and administration; 65% felt school events are well attended by faculty; 58% felt they look forward to coming to work daily; 64% felt they feel emotionally safe in school, while 67% felt they are physically safe in school; 77% felt they are appreciated when they volunteer their time for the school. The Student Climate Survey indicated: 58% of students feel respected by other students; 60% feel like they a sense of belonging at the school; 69% felt they are comfortable speaking with a staff member if they are worried about something.



### Facilities:

Our school library maintains approximately 20,000 books and multimedia space for presentations; Our cafeteria offers space for meals and community events; We have a computer lab; art and music rooms; STEM room; gymnasium for instruction and recreation, with a stage for performing arts and presentations/assemblies; physical therapy room; rooftop garden for environmental science study, with weather equipment that reports data to the Weather Bug data collection system; a Zen room for our staff; The building has achieved LEED Platinum status for environmental design and conservation-enhancing components, as well as USDoE Green Ribbon Certification.

### School Safety:

We had a school safety officer located inside the building who monitors our visitor management system. Additionally, the school, in coordination with our district's safety consultant, participated in monthly emergency drills. The staff was debriefed at faculty meetings each month following the drills. The building is outfitted with a three-tier entry system near the main office. Cameras are located throughout the school and accessed via computer for quick review.



### Technology and STEM:

Our STEM teacher sees all students in grades preK-5 weekly. Instruction takes place in the STEM room for grades k-5, as well as in the computer lab. The STEM program introduces students to the STEM/engineering design process; computer science fundamentals; computer coding/programming; building challenges; STEM terminology; content knowledge across STEM fields; career possibilities in the various STEM fields; and digital, as well as offline, resources for pursuing STEM independently with parental consent. TCI curriculum is utilized for our science program, and our environmental science classes take place at SummerWood.



### Effective and Efficient Use of ESSR Funding:

Our schools utilized beginning-of-year internal assessments as well as state assessment data to determine students' needs. Teachers analyzed the data, determined learning gaps, and developed scaffolding strategies for supporting all students. The benchmarks throughout the year were used to monitor progress. Data teams, intervention strategies, etc., were created to support students, and instructional coaches supported teachers in their efforts to accelerate learning. ESSER funds were utilized for: summer music program, security software/hardware programs, summer learning excelleration program, facility upgrades, staff wellness program

Our school operates on an 11 period day schedule. Approximately 25 percent of our population i receives ESL instruction. All classrooms are equipped with Smart Boards, Promethean Boards, televisions and other instructional technologies. We celebrated our students" diversity and abilities through our daily interactions and on special occasions, such as our Black History Month and Hispanic Heritage Month dinner celebrations. We conduct character and positive school culture activities and daily practices. Our teachers are winning grants and training their peers through turn-key training and PLC collaboration.
