Many of the test administration policies offered for greater flexibility in 2020-21 due to the pandemic are being extended this fall to make it easier to adhere to local health guidelines to support schools in administering SAT School Day. Schools should order test materials for each administration carefully, as unused test fees will apply.

- **Multiple Administration Dates:** Schools may select multiple administration dates for the SAT School Day to reduce the number of students per test date.
- Flexible Start Times: Schools can stagger arrivals and dismissals to be certain they have ample space and staffing.
- Off-Site Testing: Schools can choose multiple locations to spread out students, allowing for more distance between test takers.
