Instructions for checking your winnings

- 1. Go to the website for the Big Game Lottery and click on Search Past Results
- 2. Enter the numbers for the players on your team
- 3. Click "Search Prior Results"
- 4. Record the number of times May 17, 2002, or later that you would have won each of the prizes into a table similar to the one shown below. Ignore those prizes before May 17, 2002.
- 5. Make a table in Word that summarizes your winnings (see below).
- 6. Analyze the winnings to come up with the total winnings, total amount spent, and average winning (or loss)

The total winnings for our group were \$9. We played 2 tickets for 115 games or 230 tickets, so it cost us \$230 to play. Our net winnings are -\$221. Our average winnings per game is -\$221 / 230 = -\$0.96 or a loss of 96ϕ for each \$1 played.
