

Interstate Compact for Educational Opportunities for Military Children

1. **Purpose:** Funding is provided to support the Interstate Compact for Educational Opportunities for Military Children (“Compact”) created in 2009. The Compact’s purpose is to remove barriers to educational success imposed on children of military families because of frequent moves and deployment of their parents.
2. **Description of services provided:** The Compact is designed to facilitate the transfer of students of military personnel between schools/states. It is intended to alleviate barriers to students.
3. **Criteria for receiving services and/or grants:** Funding is for staffing for the Compact.

7. **Programmatic changes since inception (if any):** Currently, all 50 states are members of the Interstate Compact, up from only three states when Washington joined the Compact in 2009. Support is given to the Compact Council Chair to cover expenses related to his Compact Council duties.
8. **Evaluations of program/major findings:** The Compact provisions have made the transitions for military children easier. Fewer problems have arisen in the last year compared to past years. Requests for assistance have centered around graduation requirements, residency issues, and kindergarten enrollment.
9. **Major challenges faced by the program:** Changing graduation requirements across states; increasing numbers of students enrolling in schools and districts beyond the general geographic vicinity of major installations.
10. **Future opportunities:** There is an interest to offer programmatic supports to schools to better serve their students from military families.
11. **Statutory and/or Budget language:** **Budget Proviso: ESSB 6032 Sec. 501 (7)** \$61,000 of the general fund – state appropriation for fiscal year 2018 and \$61,000 of general fund – state appropriation for fiscal year 2019 are provided solely for the implementation chapter 380, Laws of 2009 (enacting the interstate compact on educational opportunity for military children).
