Mr. Hale requested The Going Green Report re: Facilities from Mr. Dan Romano be presented at the meeting on 9/1/11. The Superintendent of Schools stated that will be done.

Mr. Hornberger asked the Superintendent to give an update on projects throughout the district. The Superintendent stated that all teachers have been moved to their new locations. A major project has been started at the High School, transforming the tennis court into a parking lot. The drawings of the softball field have been finalized and will be sent out to bid. The Hampton project drawings are done and have been sent for review. It is hoped that they will be sent out to bid by the end of September or the beginning of October. The drawings for the High School art room are complete. The Superintendent stated that he will be doing a presentation of these projects at the meeting on 9/1/11. Solomon Schechter has moved in and the district is finishing up their obligations at that location. The science labs at the high school are 90% complete and all of the cabinetry is in. The life science room is complete, a kitchen and bedrooms have been added. The room is now very functional for the students. Additional office space is being added at the high school. The Superintendent stated that it has been a very busy summer. Many teachers have already come in and have unpacked to get ready for the upcoming school year. At the upcoming Administrative Retreat, Ms. Burns will be presenting on the information that she obtained in Albany. The district will be exploring a new project called "Blackboard" to extend the school day outside the building. The new webpage will be rolling out in a couple of weeks. Another new initiative is E-Spark, which will be tried in two Special Education classes. This program creates individual apps for students, based on their NWEA scores and helps reinforce skills.

Superintendents Report: The Superintendent discussed the state exam scores reported in Newsday. He stated that he was not pleased with some scores and he put together a presentation to explain these scores. The Superintendent stated that the district is below the proficiency average for Nassau County in grades 3 and 6 and is at or above average in grade 4 and 8. The Superintendent went back over scores for the past five years and found that traditionally, the 3rd graders perform poorly. Then in 4th grade the scores jump for the same group of children. In Grade 3, the ELA assessment was 66.3% proficiency. He noted that 36% of the entire grade has special needs or ESL. This is not an excuse but may be part of the reason for the scores. Another factor may be that 3rd graders are taking these assessments for the first time. In 8th grade, 13% of the grade is comprised of special needs children, which does not account for the poor numbers. In the 8th grade, there was a 59% proficiency in ELA and this same group had 80% proficiency in Math. The Superintendent stated that something appears to be going on; why is the math score so much better. The Superintendent reported that over the last two years, Mineola has experienced a trend on state exams where 90% of students were proficient but then dropped 17 points on subsequent tests. This phenomenon can be seen in all grades. The Superintendent questioned why this is happening. The state is in flux and in the process of changing the assessment tests as well as the cut scores, which are applied to control the number of students that pass or fail.

The NWEA has been put in place this year and will be used to determine children's growth from year to year. The NWEA data will drive what is done in the classroom. The Superintendent does not want to be a district that teaches to the test. He wants to see where the children are at and what needs should be addressed. The Superintendent feels current scores do not define our students. The Superintendent provided statistics from a neighboring school district; 97% of eighth graders passed their algebra regents, however only 85% passed the state assessment. He questioned why this occurred, did students

place more importance on the regents or are the test not aligned? He stated the curriculum is not aligned.

Mr. Hornberger stated that he appreciated Dr. Nagler's report, but he feels it needs to be addressed why these results occurred. He stated that the data must be analyzed and as a district we must truly look where we are missing out. Mr. Hornberger stated that we need to look at the NWEA results and evaluate where we are at and what should be done to address the results.

Mr. McGrath commented that the scores are not good and he questioned whether we are adequately servicing ESL and Special Education students. The Superintendent added that some of the students represented are serviced out of the district. He stated that we need to look how those served outside impact our scores. Mr. McGrath suggested that we compare the scores to like districts and determine their results. The Superintendent stated that he has spoken to other superintendents and they have all seen a decrease in scores.

Mr. Hornberger inquired whether we are missing something with regards to the scores. The information needs to be flushed out further. The Superintendent stated that we are a full inclusion district with only a few (5) self-contained classes. It needs to be looked at if this current model is working.

Public Comments: A parent from the district, Mr. Barnett, inquired if the use of electronics has an impact on scores and do they impact their English expression. The Superintendent stated that he and Ms. Burns have discussed teacher expectations of their students. He also added that his background is in Middle School and many scores do go down during that time period.

Another parent inquired about how to interpret her daughter's NWEA scores. The Superintendent stated the NWEA tells you what is typical growth, if your child reached that level, it is good. If not, why did they not meet the level? Ms.Burns stated that the parent could call her for further explanation.

The Superintendent stated that there is a Board Retreat on 8/17/11. Also, the calendars have been sent out; if you have not received one, call the office.

The Superintendent was in need of an executive session.
