CALVERT COUNTY PUBLIC SCHOOLS 2024 Middle School Summer School Program

The middle school summer school program is designed to meet the needs of students who were unsuccessful in one or more core courses (English/Language Arts, Math, Science, or Social Studies) during the 2023-2024 school year or who have been invited by the school to attend. Middle school students who do not pass one or more core classes are required to attend summer school to be promoted to the next grade. This integrated experience focuses on skills needed to access the requisite curriculum in the next grade.

Public school students enrolled in grades 6, 7, and 8 during the 2023-2024 school year may attend CCPS summer school.

- Students at Northern Middle, Plum Point Middle, and Windy Hill Middle will attend summer school at Windy Hill Middle School.
- Students at Calvert Middle, Mill Creek Middle, and Southern Middle will attend summer school at Southern Middle School.

SUMMER SCHOOL SCHEDULE

Middle school summer classes will begin on **Monday, July 8, and conclude on Tuesday, July 30**. The session will be 8:30 AM – 12:15 PM and will run Monday through Thursday. Students will be engaged in integrated math and science and English and social studies experiences. These experiences will build skills required in the curriculum in the next grades. This year, there is no fee to attend the summer school program.

REGISTRATION PROCEDURES

Printed copies can be obtained from the student's middle school. **Registration for summer school begins on May 20, 2024.** Approval from the principal and a school counselor is required before registration may be completed.

Printed summer school registration forms should be submitted to the school counselor. Once approved, the counselor will forward registration forms to the lead teacher at each regional site.

Final schedules are determined from the registration data. The summer school office will notify students of their enrollment for summer school by June 28, 2024.

ATTENDANCE REQUIREMENTS

Since summer school lasts for only 14 days, it is very important that participating students maintain excellent attendance. **Credit will be denied if a student misses more than one day of summer school.** Students are not excused from class for dental appointments, camp, sports, or vacations. Students who cannot attend all classes should not enroll. Students are also required to be on time for every class. If applicable, those who arrive late or leave early may not be promoted.

TUITION

CCPS Public School Student Tuition is waived Private School/Non-County Resident \$250.00

*A non-resident is a person who is permanently located outside Calvert County during the regular academic year.

If applicable, full tuition must be paid by June 28, 2024. Checks are to be made payable to Calvert County Public Schools. No tuition will be refunded if a student withdraws from summer school after attending one or more sessions.

TRANSPORTATION

Calvert County Public Schools will provide transportation during the summer term.
