SHAMOKIN AREA SCHOOL DISTRICT MINUTES OF THE BOARD OF DIRECTORS

February 15, 2022

The regular monthly meeting of the Board of Directors of the Shamokin Area School District was held Tuesday, February 15, 2022, in the board conference room in the Shamokin Area Middle/High School, with President Mrs. Melissa Hovenstine presiding. Meeting was open to the public, as well as broadcasted live over YouTube. Mrs. Hovenstine called the meeting to order at 7:30pm. Mrs. Hovenstine then led the assembly in the recitation of The Lord's Prayer and the Pledge of Allegiance to the Flag.
