Mr. Frazee presented the 2023-24 budget that was approved prior to this meeting and approved by the Executive County Superintendent.

Mrs. Thompson asked about the 2022-23 budget it was 3.7 last year. Was it over inflated? Mr. Frazee responded it was due to the grants received (ARP ESSER Funds).

Danielle Panizzi advised the Board to amend the tabled resolution. Upon motion of Mr. Sabey seconded by Mr. King the motion for the tabled resolution was amended.

Mr. Rehm discussed the Special Law Enforcement Officer Class III. Mr. Frazee presented the amended budget.
