He stated that there have been a few transportation hiccups, but families have been receptive for the scheduling changes. Materials have been hard to get, so the Sinking Fund projects have a few details left to finish. Finally, the financial audit will take place at the end of September.

Aspen Ridge Elementary School Report

Chris Marana thanked all of the teachers and staff for their flexibility and all of their extra help to start the school year as things are going well because everyone has stepped up to make it happen. He also thanked Masks for Marquette for donating masks for all students and staff, TruNorth Federal Credit Union for donating lanyards for masks and Marthaler of Marquette for donating a picnic table to add to our outdoor space. Finally, he thanked all of the families and students as they have been very understanding and receptive to all we have going on.

Middle School / Athletics Report
