## **I. Introduction**

The Miller Place UFSD Remote Learning Plan document is intended to communicate specific components of the MPUFSD plan for reopening schools in fall 2020. Based upon reflections on the emergency remote distance learning in spring 2020, review of state guidance, and feedback from our stakeholder groups, District Reopening Schools Subcommittees, and Steering Committee, the district offers three different instructional models, which are dependent upon the Governor Cuomo's direction regarding the return to school [model] in the fall. Considering feedback, these plans reflect the needs and concerns of families and staff while maintaining priorities for health, safety, rigorous instruction, and necessary support services.

In May 2020, the District approved a 1:1 device initiative in grades K-12. Dell laptops were purchased to supplement the District's existing resources to provide each student and teacher with a laptop for use in synchronous and asynchronous instruction in a remote or in-school learning environment. This means that effective the 2020-21 school year, every student and teacher will have access to a personally assigned District-provided laptop for use at home and at school to support in-school and remote learning.

With guidance and support from the assistant superintendent, the District's director of technology and feedback from the District's reopening schools technology subcommittee, the District is reviewing various options for assigning and signing out District devices.

After feedback from the District Reopening Task Force, Learning and Instruction, and Technology Subcommittees, as well as community feedback in July 2020, the District adopted a new learning management system, Google G-Suite to replace Microsoft 365 (Teams). The District is planning focused and intensive professional development for teachers and administrators, with opportunities for staff to participate in at least nine hours of Google professional development prior to the start of school. The District is also planning to provide students and families with orientation and instructional videos which will be posted to the District website prior to the start of the school year. Students will receive their devices upon their return to school. In the case where schools do not open, and students begin the school year in a 100% remote learning environment, the devices will be distributed according to a plan that is to be determined.

The District will continue to partner with internet service providers to expand free and low cost home internet service options for the community as available. The District may contact students and staff to assure that every student/family and staff has equitable access to internet service.

Regardless of the instructional model, digital resources help provide consistent and equitable access to learning. Staff will continue to engage in professional development opportunities to implement digital resources in combination with high quality instructional strategies.

## II. Remote Learning Models Defined

Remote learning is instruction that takes place outside of the school building while the students are not in attendance at the school. Remote (online) learning models include synchronous (live interaction) and asynchronous instruction. The District currently offers a full remote learning model provided by Eastern Suffolk BOCES or the Miller Place faculty for students in grades K-6 only. Parents must inform the district of their intent for their child (grades K-6 only) to participate in the full remote model by no later than Tuesday, August 18, 2020.

On-site instruction: Instruction that takes place with students and teachers in attendance at the school building.

A hybrid (blended) learning model is a combination of on-site (in-person) and remote learning.

## IV. Hybrid Learning Model Schedules

In the hybrid model, instructional delivery requires a reduced schedule of on-site learning. Students participate in remote instruction on a learning management system, *Google*, on days when they are not in a school building. The hybrid models include a rotating day schedule for on-site and remote instruction for two cohort groups. Students are assigned into cohort group 1 or 2 based upon an alphabetical split by last name. Families with different last names may follow the schedule of the eldest child in the household. Secondary students will follow an A Day/B Day schedule for purposes of labs and (class) rotations.

The hybrid model allows for remaining connected with a methodology to support student learning while at home. All students will have access to and interaction with an appropriately certified teacher to the extent possible.

A. Grades K-2:

Elementary school students will participate in core subjects each day that they are learning on-site in school and specials on a rotating schedule. Wednesday synchronous instruction will include a modified schedule where all students will logon with a teacher.

The schedule below demonstrates a sample of a hybrid learning model for AMPS students.

D. Grades 7-12:

Secondary students will follow a nine-period day schedule inclusive of core and encore subject area classes. The on-site bell schedule will include extra time for students passing between classes. The Wednesday synchronous instruction will follow a modified nine period day schedule with students signing on for each class as per their regular on-site learning instruction schedule. The Wednesday synchronous instruction schedule will follow an A day or B day rotating schedule.

E. Livestreaming of Instruction (added 10/28/20):

1. Rationale for live streaming of classroom instruction
  - a. Allows the Hybrid Plan to stretch the curriculum to 5 days per week (as opposed to the current 2 days in-person and 1 day remote).
  - b. It would allow all current instructional plans (secondary and elementary) to have five days of curriculum each week.
  - c. On the secondary level, in the event the District needs to move to a full virtual or full in-person, the transition for curriculum would be seamless.
  - d. Secondary teachers would not need to plan lessons, materials, assignments and videos for the days they do not meet with students for in-person (asynchronous days).
2. Secondary Live Streaming Schedule to be implemented November 5, 2020:
  - a. Monday: In-person teaching for Cohort 1; Live stream virtually students in Cohort 2.
  - b. Tuesday: In-person teaching for Cohort 1; Live stream virtually students in Cohort 2.
  - c. Wednesday: Virtual teaching Cohort 1 and Cohort 2.
  - d. Thursday: In-person teaching for Cohort 2; Live stream virtually students in Cohort 1.
  - e. Friday: In-person teaching for Cohort 2; Live stream virtually students in Cohort 1.
3. Live Streaming Practice:
  - a. Students receiving the live streaming will view the SMARTBoard and hear the live teacher audio of the lesson. For the 2020-21 school year, camera access will be voluntary and at the discretion of the teacher.
  - b. In the event the SMARTBoard is not being utilized during the lesson, live streaming students would still view the SMARTBoard or screen shot (i.e. Picture of a school) and only receive the audio.
4. Wednesday Virtual Instruction suspended effective November 18, 2020 and will be replaced with in-person and asynchronous instruction as follows: (Added 10/28/20)

5. Student Rosters:
  - a. Students receiving live streaming instruction are responsible for the material covered.
  - b. Student attendance will be recorded for all students on the roster daily.
  - c. Students attending class completely remote are part of the teacher's original class roster. These students would be attending these classes if school was completely in-person. While in the Hybrid Plan, these students will live stream Mondays, Tuesdays, Thursdays and Fridays and virtually on Wednesdays.
    - i. Students who are removed from the classroom setting for discipline reasons will not be permitted to participate in live streaming instruction.
    - ii. Cases where students who are medically challenged, will be reviewed on a case by case basis to determine if they can participate in live streaming instruction.
6. Third Party Observing and Complaints of Live Streaming Lessons:
  - a. Third party observing and complaints of live streaming lessons, such as from a parent/guardian, will not result in teacher discipline.

- b. Any investigation into concerns in a classroom will be contingent upon in-person, first-hand observance (students, administrations etc.). Any investigation will be conducted by interviewing individuals in attendance.
  - c. To protect teachers from having their image, likeness, and/or voice misappropriated by students, parents, or others in the home, the District will confirm that students and parents have signed the Acceptable Use Policy and received Digital Citizenship information.
7. Student misbehavior on the remote platform: The following information is the current language included in the 2020-21 Code of Conduct, and applies to live streaming:

Inappropriate student conduct while participating in virtual or remote learning includes:

- a. Failing to comply with the reasonable directions of teachers, school administrators or other school employees in charge of students, or otherwise demonstrating disrespect.
- b. Any behavior that stops a teacher from teaching and students from learning.
- c. Threatening to use any weapon or violence upon any person.
- d. Defamation
- e. Discrimination
- f. Cyberbullying
- g. Intimidation
- h. Using vulgar or abusive language, cursing or swearing

Students engaging in misconduct may result in the teacher disconnecting the student immediately.

Actions by a parent, guardian, sibling or non-student that are visible or audible while the student is participating in virtual or remote learning, may result in the teacher disconnecting the student immediately.

Students who violate the Code of Conduct, as it applies to digital citizenship, are subject to one or more of the following penalties:

- a. Oral warning
- b. Written referral
- c. Oral notification
- d. Written notification to parent
- e. Detention
- f. Removal from individual school functions
- g. Suspension from athletic participation
- h. Suspension from social or extracurricular activities
- i. Suspension of other privileges

- j. In-school suspension
- k. Removal from classroom by teacher
- l. Short-term (five days or less) suspension from school
- m. Long-term (more than five days) suspension from school
- n. Permanent suspension from school

In addition, the District considers appropriate student digital citizenship to include:

- a. Arrive online at the scheduled time
- b. Do their best to try to find a quiet place free from distractions whatever environment they are learning in
- c. Be prepared with all lesson materials
- d. Maintain respect in speaking, writing, and appearance
- e. Identify themselves clearly with their name on the screen. Unrecognizable and unidentifiable usernames are not acceptable
- f. Mute themselves when they enter a live session to limit background noise and distractions to others
- g. Use the chat feature when available to ask questions
- h. Keep video on during live sessions when comfortable
- i. Follow teacher instructions throughout the session
- j. Use the chat feature to message the teacher privately, unless otherwise directed by the teacher
- k. Students are prohibited from using the remote learning platform for any other purpose other than their intended use as directed by the teacher
- l. The use of headphones or earbuds while engaging with audio or video content is strongly encouraged. This will help them focus on learning and not be distracted
- m. The privacy and confidentiality of all participants is important. The following are prohibited during the live sessions, unless approved by the teacher:
  - i. Taking photos or screenshot
  - ii. Taking videos
  - iii. Altering content presented by the teacher
  - iv. Sharing, posting or otherwise distributing, in any matter either physically, or electronically via, email, text or social media platform any session or content.
  - v. Sharing login information, links, ID numbers, passwords or invitations to live sessions with anyone.
- n. The standards of behavior for students will be enforced to ensure students will not:
  - i. Make inappropriate faces, gestures or comments
  - ii. Wear full facial covering masks, such as a Halloween masks
  - iii. Display inappropriate virtual background or profile picture
  - iv. Project or display an inappropriate image

In cases of inappropriate student conduct, a teacher may stop the virtual feed during the lesson and will notify a building administrator as per the Code of Conduct noted above.

**F. Full-time Live Stream Option**

1. Effective Monday, January 11, 2021, parents will be given the option for their child to participate in live stream classes full time – five days per week, for each class.
2. The full-time live stream option will provide students an instructional program with limitations. For example, there may be classes, such as labs, where the in-person students in the hybrid model will have a richer and/or fuller educational experience than students who are live streaming all their classes.
3. Although teachers will be live streaming instruction to the hybrid model students at home and to the full-time live stream students, their primary focus will remain on the delivery of instruction to students who are in-person.
4. Listed below is a quick summary of the full-time live stream option being offered at this time:
  - a. The full-time live stream option is for the remainder of the 2nd quarter – Monday, January 11 through January 29, 2021, while the secondary instructional program remains the hybrid model.
  - b. The parent and student commitment must be for the full three weeks remaining in the second quarter.
  - c. In order to participate in this 2nd quarter option, parents of high school students must email their intention and commitment to the building principal with the email subject line “Live Stream Student.”
  - d. Once the email notification is received, the Principal, or his designee, will notify the child’s teachers that the student will be attending classes via the full-time live stream model for the next three weeks.
5. Students will:
  - a. Be expected to live stream into each class on their current schedule, via their Google classrooms, period by period on each day school is in session (Monday – Friday).
  - b. Need to be present for attendance purposes in each class just as if they were attending class in-person. If they are not present, they will be marked absent.
  - c. Complete all assignments in alignment with in-person students.
  - d. Participate in testing and assessments as instructed by their teacher.
  - e. Communicate with faculty via the Google chat during class, via email, and/or as determined by their teacher.
  - f. Be able to participate in after-school co-curricular activities, such as athletics and clubs (virtually and in-person) if they are participating in the full-time live streaming classes option.

6. The District will evaluate the effectiveness and student participation level of the secondary full-time live stream option to determine if the option should be extended for the 3rd quarter (February 1 – April 16, 2021).

G. Full time in-person Instruction (added February 24, 2021)

1. In-school days where students are expected to return to five days per week.
2. This eliminates the hybrid (cohort) model as of March 1, 2021.
3. It is anticipated there will not be 6 foot social distancing in classrooms, computer labs, libraries, hallways, cafeterias, gymnasiums and the auditorium.
4. Classroom student desk shields will remain in place.
5. Masks will still be required at all times, except when eating/drinking. There will no longer be scheduled mask breaks. Individual students may request a mask break from their teacher if needed.
6. Passing time will remain at 5 minutes to allow students and staff to move through the hallways at a slower pace. (We are not returning to 3 minute passing time.)
7. No use of hallway lockers.
8. We will continue to review the use of locker rooms during February 2021.
9. We will maintain the process of taking student temperatures upon arrival at school.
10. We will maintain the “No Visitor” practice.
11. Transportation bus routes, drop-off, and pick-up procedures will remain the same.

H. Live Stream Options:

1. Student Live Streaming (Full 3<sup>rd</sup> Quarter) February 1 – April 16, 2021:
  - a. Students will have the option to 100% live stream classes for the entire 3<sup>rd</sup> quarter, February 1 – April 16, 2021.
  - b. Students who choose this option must commit for the entire 3<sup>rd</sup> quarter.
  - c. Students will have the option to return to in-person instruction for the 4<sup>th</sup> quarter or remain 100% live streaming classes for the 4<sup>th</sup> quarter.
  - d. The deadline for parents to notify Mr. Slavin or Mr. Clark is Thursday, January 28, 2021.
2. Students Remain Hybrid for February and Begin Live Streaming March 1 through April 16, 2021 (Remainder of 3rd Quarter):
  - a. Students will have the option to remain hybrid for February 2021.
  - b. On March 1st when students return to school full-time, students may opt for 100% live streaming classes for the remainder of the 3rd quarter.
  - c. Students will have the option to return to in-person instruction for the 4th quarter or remain 100% live streaming classes for the 4th quarter.

- d. The deadline for parents to notify Mr. Slavin or Mr. Clark is Tuesday, February 23, 2021.
- I. In the event where students are not reporting to school (weather-related or non-weather related), and the District needs to transition to a remote learning day for students, any one of the following scenarios may be implemented.
  - 1. Scenario A – Full Day Remote Learning
    - a. Teachers, teacher assistants, and teacher aides instruct from home and students learn from home (*ex. weather related or building emergency*):
      - AMPS students log onto their Google Classroom from home at 9:15am and follow their regular in-school schedule.
      - LADSBS students log onto their Google Classroom from home at 8:30am and follow their regular in-school schedule.
      - NCRMS students log onto their Google Classroom from home at 7:35am and follow their regular in-school schedule.
      - MPHS students log onto their Google Classroom from home at 7:07am and follow their regular in-school schedule.

**-OR-**

- b. Teachers, teacher assistants, and teacher aides instruct from school and students learn from home (*ex. contact tracing, prolonged closure, or emergency situation resolved*):
      - AMPS students log onto their Google Classroom from home at 9:15am and follow their regular in-school schedule.
      - LADSBS students log onto their Google Classroom from home at 8:30am and follow their regular in-school schedule.
      - NCRMS students log onto their Google Classroom from home at 7:35am and follow their regular in-school schedule.
      - MPHS students log onto their Google Classroom from home at 7:07am and follow their regular in-school schedule.
  - 2. Scenario B – Delayed Opening/Remote Learning
    - a. Teachers, teacher assistants, and teacher aides instruct from home and students learn from home (*ex. weather related or building emergency*):
      - AMPS students log onto their Google Classroom from home at 10:15am, 11:15am or 12:15pm and follow their regular in-school schedule.
      - LADSBS students log onto their Google Classroom from home at 9:30am, 10:30am or 11:30am and follow their regular in-school schedule.
      - NCRMS students log onto their Google Classroom from home at 8:35am, 9:35am, or 10:35am and follow their regular in-school schedule.

- MPHS students log onto their Google Classroom from home at 8:07am, 9:07am, or 10:07am and follow their regular in-school schedule.

**-OR-**

- b. Teachers, teacher assistants, and teacher aides instruct from school and students learn from home (*ex. contact tracing, prolonged closure, or emergency resolved*):
  - AMPS students log onto their Google Classroom from home at 10:15am, 11:15am or 12:15pm follow their regular in-school schedule.
  - LADSBS students log onto their Google Classroom from home at 9:30am, 10:30am or 11:30am and follow their regular in-school schedule.
  - NCRMS students log onto their Google Classroom from home at 8:35am, 9:35am, or 10:35am and follow their regular in-school schedule.
  - MPHS students log onto their Google Classroom from home at 8:07am, 9:07am, or 10:07am and follow their regular in-school schedule.

J. Day to Day Livestream Option (added 6/10/210)

1. Elementary: The following daily remote option will be available to Andrew Muller Primary School and Laddie A. Decker Sound Beach School students as follows:
  - a. Parents need to notify the attendance office prior to the start of school on the day they are planning to keep their children home due to weather conditions. This is the same procedure if a student is being called in sick.
  - b. Teachers will post ELA and math assignments in their Google classroom for your child to complete. We anticipate the assignments will be posted by 10:30a.m.
  - c. Students that are opting to learn from home on a given high heat day will be marked as an “excused absence.”
2. Secondary: The following daily livestream (virtual) option will be available to North Country Road Middle School and Miller Place High School students as follows:
  - a. Parents need to notify the attendance office prior to the start of school on the day they are planning to livestream. This is the same procedure if a student is being called in sick.
  - b. Students that are opting to livestream on a given day will be marked “present” by the classroom teacher once they are identified in the livestream.
  - c. Students that are livestreaming will be expected to be present and participating in each class in order to be marked present in attendance.

- d. Students that are opting for a day to day live streaming option will not be permitted to take their final exam from home. If they are not present in the building during a final exam, they will need to make up this test when they return. (No final exams will be given to daily livestream students who are learning from home.)
- e. Students that are livestreaming on any day will be permitted to participate in extra-curricular activities for that day. These activities include athletics, clubs, concerts, and awards nights.
- f. Please note: A student who had previously committed to livestream for 4th quarter (remainder of the school year) will continue to take in-class assessments at home. As previously stated, students who have opted to take regent exams need to be in the building the day of the exam (regent exams cannot be taken at home).

## V. Full Remote Learning Model Schedules

This model includes five days of remote, teacher-directed, synchronous instruction. In the case where the district is directed to implement a full time remote learning model, remote learning schedules will be finalized and communicated to students and families.

### A. Grades K-5:

Elementary students will follow a modified schedule to accommodate a full instructional model that is social and emotionally and developmentally appropriate for elementary students including but not limited to periodic breaks from learning and opportunities for cooperative learning and peer collaboration.

The schedule below demonstrates a sample of a full remote learning model for elementary students grades K-5.

## **VI. Special Education**

### **A. Special Class and ICT Classes:**

1. Students within secondary buildings who are placed by the CSE into a Special Class for core academics are on-site **5** days per week.
2. Students within secondary buildings who are placed by the CSE into a combination of Special Class as well as integrated co-teaching (ICT) will be on-site **5** days per week.
3. Students within a secondary building who are placed by the CSE either in a resource room or a full ICT program will be on-site as per their appropriate cohort.
4. Students within the elementary buildings will be on-site 5 days per week.

### **B. Career and Technical Education:**

1. In-school live streaming for Occupational Education students to be implemented November 23, 2020 (added 11/18/20):
  - a. Change the instructional Occupational Education hybrid model so that all Occupational Education students will live stream from within the Miller Place High School on live stream days.
  - b. Occupational Education students will participate in the in-school livestreaming instructional model from a designated location/room within the Miller Place High School.
  - c. Student participating in the in-school live stream instructional model, will be supervised by Miller Place staff while they are live streaming.

## **VII. Glossary of Terms:**

All the time access is a reference to the National Educational Technology Plan, which states the expectation that technology-enabled learning should be available for all students, everywhere, all the time (NETP 2017).

Asynchronous learning: Asynchronous learning is scheduled independently with the ability to access and satisfy classroom requirements within a flexible time frame. Methods of asynchronous online learning include self-guided lesson modules, streaming video content, virtual libraries, posted lecture notes, and exchanges across discussion boards or social media platforms.

Device: A computing device, such as a laptop, desktop, Chromebook, iPad, or full-size tablet. Phones and mini-tablets are not sufficient devices for learning purposes.

Hybrid (blended) model: A combination of in person and remote learning.

In-person instruction: Instruction that takes place with students in attendance at the school building.

On-site learning: Instruction that takes place with students and teachers in attendance at the school building.

Remote learning: Instruction that takes place outside of the school building while the students are not in attendance at the school.

Sufficient access to the internet means that the student or teacher does not regularly experience issues (slowdowns, buffering, disconnections, unreliable connection, etc.) while participating in required or assigned instruction and learning activities.

Synchronous learning: Synchronous learning happens in real time. This means that students and teachers interact in a specific virtual place, through a specific online medium, at a specific time. Methods of synchronous online learning include video conferencing, teleconferencing, live chatting, and live-streaming lectures.
