Examine the evidence and bindle your evidence recording the information about the evidence on the evidence tags. Below is a list of instructions that will help you in Bindles and identification.

- 1. Identify the bones and group the bones as shown on the identification chart. You will keep each skull separate in a bindle.
- 2. Group bones as shown on the identification chart together (Example: Rodent hips) in the same bindle.
- 3. Do not discard any of your evidence; this includes all hair and bones. Note:


4. How to label the bindles:

- 6. Place all evidence back into the original, seal, and sign it correctly.
- 7. Turn in to the Evidence into the Evidence Vault.
- 8. Clean up your work area. THIS IS EVERYONE'S RESPONSIBILITY and you will lose points(20 points).

You will mark the case number and complete the evidence log with all pieces of evidence listed. You will need to bag all labeled evidence into the collection bag with your group name on it.

An Arrest warrant

An arrest warrant gives police the power to arrest the person named in the warrant so that person can be brought to court.

The arrest warrant will include:

- The person to be arrested
- the offence you're accused of
- an order to arrest you
- the signature or name of the judge or justice of the peace who ordered the warrant

A police officer can swear an information if they have reasonable and probable grounds to believe you have committed a crime. An information is an official court document charging you with an offence. A judge or justice of the peace decides whether to issue an arrest warrant based on the information.

Having reasonable and probable grounds is more than having a suspicion or hunch based on the facts. The officer must believe that any reasonable person in the officer's position would think there are grounds to believe you were involved in a crime.

The judge or justice of the peace decides whether to issue an arrest warrant or an appearance notice after reviewing the information.

You will need to fill out the arrest warrant for the person responsible for the murder. You will also need to determine the count:

States have adopted several different schemes for classifying murders by degree. The most common separates murder into two degrees (first and second degree murder), and treats voluntary and involuntary manslaughter as separate crimes that do not constitute murder.

- **First-degree murder**: any intentional murder that is willful and premeditated with malice aforethought. Felony murder, a charge that may be filed against a defendant who is involved in a dangerous crime where a death results from the crime, is typically first-degree.
- **Second-degree murder**: any intentional murder with malice aforethought, but is not premeditated or planned in advance.

- Voluntary manslaughter: sometimes called a crime of passion murder, is any intentional killing that involves no prior intent to kill, and which was committed under such circumstances that would "cause a reasonable person to become emotionally or mentally disturbed". Both this and second-degree murder are committed on the spot under a spur-of-the-moment choice, but the two differ in the magnitude of the circumstances surrounding the crime. For example, a bar fight that results in death would ordinarily constitute second-degree murder. If that same bar fight stemmed from a discovery of infidelity, however, it may be mitigated to voluntary manslaughter.
- Involuntary manslaughter: a killing that stems from a lack of intention to cause death but involving an intentional, or negligent, act leading to death. A drunk driving—related death is typically involuntary manslaughter (see also vehicular homicide, causing death by dangerous driving, gross negligence manslaughter and causing death by criminal negligence for international equivalents). Note that the "unintentional" element here refers to the lack of intent to bring about the death. All three crimes above feature an intent to kill, whereas involuntary manslaughter is "unintentional", because the killer did not intend for a death to result from their intentional actions. If there is a presence of intention it relates only to the intent to cause a violent act which brings about the death, but not an intention to bring about the death itself
