

North Marion School District Bring Your Own Device (BYOD) Permission Form

Student and Parent Instructions: Please review these guidelines. Sign and return this page to your student's teacher.

- High School students are allowed to bring a personal mobile device to school after they have completed a signed BYOD Permission form. Students are NOT required to bring a personal mobile device to school.
- 2. The student and their parent/guardian must sign and return this form before the student may participate in BYOD.
- 3. Students may only bring **one** mobile device limited to the following device types: laptops, netbooks, tablets & eReaders (such as Kindles or Nooks). Mobile phones and gaming devices are not allowed to participate in BYOD.
- 4. Students are not to share their login information with anyone else or attempt to use on more than the one device listed on this permission form.
- 5. Students are expected to know how to operate their personal devices. North Marion teachers, staff and Technology department will not provide technical support or troubleshooting advice to students.
- 6. Students must use the NMSD-DayPass wireless network (WiFi) connection when accessing the internet or online content when on North Marion's campus. Students are not allowed to create or join unauthorized wireless networks or "Hotspots" or to connect to North Marion's wired network.
- 7. Students must not engage in hacking type behavior, that can be briefly described but not limited to: unauthorized intrusion into a computer or network to gain privileged access or cause harm or act in a malicious way. A partial listing of forbidden activities would include: Vulnerability Scanning, Password Cracking, Packet Sniffing, Spoofing, Root Kit, Trojan horse, Viruses and Key Loggers
- 8. Students must not attempt to bypass internet filtering by using such services, but not limited to VPN, Anonymous Web Proxys, SSH tunneling, Tor or UltraSurf.
- 9. Students may use personal devices in class for educational purposes only and when not in use should be silenced or powered off.
- 10. Students must comply with North Marion's School District Internet Use, Student Email & Google Apps for Education Policy.
- 11. Students may not use their device in a way that disrupts the educational environment, violates the rights of others, or invades the privacy of others, including but not limited to using the device to cheat, to violate school conduct rules, to harass or bully students or staff, or for unlawful purposes.

- 12. Prior to recording audio or video or taking pictures, students must obtain permission from a teacher or administrator and the person being recorded or photographed. The student must also obtain separate permission before publishing, posting, disseminating, sharing, or transferring recordings or images.
- 13. Students may not take, publish, post, disseminate, share or transfer recordings or images that reveal private parts of the body that are ordinarily covered by clothing. Students may not possess pornographic images or video on any electronic device.
- 14. North Marion School District is not responsible for theft, loss, or damage to a students' personal device or to content on the device while at North Marion or connected to the North Marion network. North Marion is not liable for content already on the student's personal device. North Marion is not responsible for any monetary charges that may occur while the student is using the device.
- 15. A student who violates these guidelines may face disciplinary actions, up to and including loss of privileges, expulsion and/or referral to law enforcement.
