

## Student Growth

Student growth is a measure of how much students are learning each year. New Jersey's ESSA state plan outlines that academic progress will be measured with school's median student growth percentile (mSGP) on statewide ELA and mathematics assessments. Each individual student receives a Student Growth Percentile (SGP) for English Language Arts (ELA) in grades 4 through 8 and for Mathematics in grades 4 through 7. The SGP measures their academic progress from one year to the next compared to other students with similar prior test scores (academic peers).

A student's SGP falls between 1 and 99 and can be grouped into three levels. An mSGP below 35 indicates low growth, an mSGP between 35 and 65 indicates typical growth, and an mSGP greater than 65 indicates high growth. If the SGPs for all students are ordered from smallest to largest, the mSGP is the percentile in the middle of the list.

**Important Note for 2022-23:** Student growth data is not available for the 2019-2020, 2020-2021, and 2021-2022 school years due to federal waivers and assessment cancellations. An alternate measure of academic progress, or growth, called Relative School Improvement Measure (RSIM) was used for the 2021-2022 school year only.










### English Language Arts and Mathematics Performance Trends



The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. Students who were enrolled for less than half a school year are excluded from performance results. 



Additionally, end-of-course assessment results for Geometry and Algebra II for 2018-19 and prior years included all students in middle school and grades 9 and 10. The requirements for high school testing changed in 2021-22 so that students are only required to take the NJSLA once in high school. Therefore, 2021-22 and 2022-23 data for Geometry and Algebra II may not be comparable to data from 2018-19.







This graph shows the percentage of K-12 students by the number of days they were absent during the school year.







Schools that were identified for CSI or ATSI status in fall 2022 were eligible to exit status at the end of the 2023-2024 school year if all exit criteria were met. ### Before and After School Programs:

Neptune Middle School offers after-school homework assistance in all subject areas four days a week. Students also use the facilities for after-school clubs and sports.



### Staff and Professional Learning:

Grade level and department level Professional Learning Communities meet daily. Staff members are encouraged to turn-key information to staff during PD days and faculty meetings. Topics include but are not limited to SEL, Trauma Informed Schools, technology, literacy, data driven instruction, and school safety. The district provides varied PD throughout the year to address district and school goals which are intertwined with staff and student needs. Opportunities for faculty growth are available through relationships with Rutgers University, PBSIS, NJAMLE and other professional organizations.



### Student Supports and Services:

NMS provides an English as a Second Language program for those qualifying students, a magnet school program for Deaf and Hard of Hearing learners, general education, and specialized education classes. Affiliations exist with the Monmouth County Arts Middle School program, Prevention First and the Monmouth County Vocational program. Counseling is available through the YMCA. Effective School Solutions is also housed within the building providing additional counseling and support services.
