The Superintendent of Schools congratulated Mr. Freeman, Mr. Feinberg and the Mineola Marching Band for placing first at the New York State Marching Band Competition in Syracuse, NY, and thanked the Board of Education for their support of the Marching Band.

A discussion ensued regarding a District Cell Phone Policy. Mr. Hornberger asked the Superintendent of Schools what the monthly cost of cell phones is to the district and the Superintendent responded that the monthly average is approximately \$1400 for 103 phones, including the Transportation Department. The Superintendent of Schools stated that he feels that if the District wants to be able to reach certain Administrators at any time, then the district should provide cell phones, adding that he recommends a flat monthly fee for personal use of District phones for The Superintendent, the Director of Facilities, the Director of Transportation, the Director of Athletics and possibly the Director of Fine Arts. The Superintendent stated that a decision did not have to be reached tonight, and Mr. Hornberger suggested that they have another dialog by the next Board meeting.

Mr. Hornberger stated that, since the Homecoming Parade had been cancelled due to inclement weather, there was a suggestion made by the High School students that they join the Mineola Athletic Association's parade in the spring. This matter will be discussed further at a later date.

I. Superintendent's Reports

The Superintendent of Schools introduced Sharon Macken and Sherri Goffman who presented the 2008-2009 Annual Report, discussing Summative and Formative Assessments, defining Like Pairs, and an overview on scoring of standardized tests. S.M.A.R.T. Goals will be discussed at the December 3rd Board meeting.

The Superintendent of Schools stated that the Marching Band had a great weekend, placing first in the New York State competition in Syracuse, the Girls' Volleyball team had a great game on Wednesday and the Boy's Soccer team lost to Jericho. Dr. Nagler gave an update on flu cases in the district, stating that it was still early in the season, but that numbers were low, with 16 cases in 7 buildings, adding that this number reflects all flu cases and not specifically H1N1, as many doctors are not making the distinction any longer.
