A. Call to Order

At 6:30 p.m. the meeting was called to order by President Hornberger.

At 6:30 p.m. a motion was made for the Board of Education to go into executive session to discuss the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation at the recommendation of the Superintendent of Schools.

At 7:00 p.m. the Board of Education returned to open session and recessed the meeting so the Board could make their way to the Staff Lounge for the open meeting.

At 7:07 p.m. the meeting resumed.

- E. Dais & Visitor Introductions

After introduction of the dais, also in attendance were: Peter Freeman, Supervisor of Fine and Performing Arts; and Dan Romano, Director of School Facilities & Operations.

F. High School Student Organization Report

The High School Student Representative reported on the following: meeting with the Superintendent of Schools to discuss the cafeteria food; bringing back the morning talk show at the High School; bringing back the Buddy System when Middle School students visit the High School; survey the entire High School student body as to what should be done with tennis courts; and two fund raisers for the Thanksgiving Food Drive.

At this time President Hornberger stated that the agenda will move some items around in order to hear public comments. President Hornberger stated that a number of people in the audience wish to speak about a personnel issue and announced that no question will be responded to regarding specific personnel.

Public comments were as follows:

❖ A parent commented about the removal of a Principal from a school and stated the children have a right to know why, and that they should have had an opportunity to say good-bye. The parent stated there are speculation and rumors going around. The parent asked the following questions as well as commented on the Principal's departure: if it was a legal matter; who was in charge of monitoring the students; the

Principal is dedicated to the children and can be found at the school early morning and late at night; and wants to know what the parents can do to keep this Principal. President Hornberger responded that he appreciates her comments. The Superintendent of Schools responded that when a Principal is away from the building a designee is assigned.

- A parent questioned the following: putting a High School Asst. Principal in charge of an elementary school and if it was in the best interest of the children; and if the designated person in charge, prior to the Asst. principal being assigned there, was certified in Administration. The Superintendent of Schools responded that he was not aware if they were certified in Administration, but in the temporary absence of the Principal they can take over temporarily. The Superintendent of Schools also stated that he does not know the length of time the Principal would be out and further stated that the High School Asst. Principal was more than qualified even though he would not be the first choice for an elementary principal.
- ❖ A parent inquired if a child was hurt. The parent further commented that in the past, other people were not removed from their positions regarding litigation. The parent spoke about the type of letter they received from the district and felt it was an inappropriate way to handle the situation.
- ❖ A parent commented that when she first came to the district, she had difficulties and the Principal went above and beyond to make sure her son was okay, and expressed dissatisfaction in the Principal's removal. The parent stated that there is much support for this Principal and will do whatever it takes to bring them back.
- A parent commented that all her experiences in working with the Principal were positive. The Principal responds to e-mails all hours of the day and night and was always accessible to the parents. The parent stated that it is the responsibility of the district to communicate better with the families, and not by the type of letter that was sent home.
- A parent commented about seeing the Principal's car at the school day and night.
- ❖ A parent alluded to rumors that the Principal was fired and asked whose decision it was to take her out of their school. President Hornberger responded that the Board had been advised not to discuss the matter. The parents inquired if the Board was advised by legal counsel. President Hornberger responded yes. The parent inquired about submitting a FOIL and addressed Mr. McGrath and Mr. McGrath referred to the Board's President. Mr. McGrath then responded that the information would not be provided because it was a personnel issue and would be exempt.
- ❖ A parent made the following comments: the Principal is a terrific individual; very dedicated to the children; felt this was vindictive toward the school and their feeling is that they must fight for everything they get referring to class size. President Hornberger asked Ms. Goffman how many children were at Cross Street in the 5th grade. Ms. Goffman responded that she has to look that information up. Another parent corrected the grade level as 2nd grade and not 5th. President Hornberger responded that he would like to see both numbers.

G. Old Business

Ms. Salvatore requested clarification if the new policies would be presented at the next Board meeting. President Hornberger responded that the policies will be distributed and reviewed, but the Code of Conduct comes under a deliverable from Central Office, possibly December. Ms. Salvatore stated that she is reviewing policies from other districts.

Mr. Hornberger inquired about the signage (Mustang Pride) at Hampton Stadium. The Superintendent of Schools stated that it is part of the bleacher project. He is looking for direction from the Board as to how they would like to proceed with the Press Box. Ms. Salvatore suggested adding electricity for lights for evening games. The Superintendent of Schools stated that no ground work is slated. Mr. McGrath inquired as to the need for a Press Box. The Superintendent of Schools responded that height is needed to view the field. Ms. Napolitano commented that it was a lot of money for a Press Box. Ms. Salvatore suggested waiting for the bids to come in for the bleachers before committing to a Press Box. Mr. Hornberger stated that Administration was looking for approval for the demo and bleacher work right now. The Superintendent of Schools stated that if the Board is not contemplating a Press Box Administration will address the plan because the Press Box is connected to the bleachers and would not recommend moving forward if the Press Box was not included. The cost comes in because the Press Box is suspended atop the bleachers. Ms. Salvatore inquired if it would have electricity. The Superintendent of Schools responded, yes. Mr. Hornberger inquired as to an alternative. Mr. McGrath asked if there was a need for the Press Box. The Superintendent of Schools responded, yes. The Board gave direction to move forward.

Mr. Hornberger inquired about the Science wish list. The Superintendent of Schools stated that he and Mr. McGrath met with the ILs and a recommendation will be forthcoming.

Mr. Hornberger inquired about the response the district received from the ads for volunteers. The Superintendent of Schools responded that he received one for Finance. Mr. Waters stated Ms. Darmstadt made 2 suggestions, and there are 3 potential participants.

Superintendent of Schools responded that the Principal's replied there was interest in these clubs. Mr. McGrath inquired when the stipends were approved would they be paid out. The Superintendent of Schools stated that if there were not enough students to run the club, the stipends would

not be paid out because they are paid to meet with students. Ms.

Napolitano referenced one of the Superintendent of Schools' deliverables regarding teachers taking attendance. The Superintendent of Schools stated that the directive has already gone out and he will conduct a mid-year 2-part analysis (If the club is viable and whether or not there was

J. Public Comments

The public comments were as follows:

A resident described a program (Playground Pals at Meadow) and inquired about approving it as a club with a stipend. The parent then described the benefits of this program. The Superintendent of Schools requested clarification if the parent was asking why it was not a club. He is aware of the program and explained that clubs and stipends are negotiated with the bargaining unit. All clubs run free for the first year and if successful a request is made to put it in the budget for the following year. He further stated that the Principal has spoken to him about this program a few times. The resident made a suggestion; after receiving bids for the Press Box, if they come in lower than anticipated the remaining money could be used to support this program. The resident requested explaining how the process works for establishing a club and stipend. The Superintendent of Schools responded that the stipend is negotiated in

- the teachers' contract. He further explained the following: stipends were not based on a specific rule; a set of standards needs to be set; and there needs to be student interest. The parent asked if a teacher needs to express interest in running it. The Superintendent of Schools responded, yes and it is unit work. Mr. McGrath stated that parents cannot encourage a teacher to develop a club, they are arbitrary.
- ❖ A resident commented on a club at Meadow that ran 3 years ago (TV Crew) and due to a fire they had in the building the club had to disband. They were told by the former Superintendent that everything would be up and running and it still is not functioning. The Superintendent of Schools stated that it will look better with a projector on a promethean board and that specific wiring is needed for every TV. The resident responded they were working on it prior to the fire. The Superintendent of Schools stated that he would rather do it with the new technology rather than old technology. The Superintendent of Schools chose a 3rd grade parent from the audience and asked if a promethean board was in her child's class. The parent responded yes.
- ❖ A parent complained about the manner in which parents were communicated with regarding the Principal leaving their school.
- A parent inquired as to the types of personnel matters that cannot be addressed. President Hornberger stated he could not address the question. The parent inquired as to a time frame the Board will communicate with parents, and could the Principal speak with parents. President Hornberger stated the Board cannot discuss this issue and it would be the Principal's decision.
- ❖ A parent inquired if there was any truth to a rumor that the Principal would be returning on Monday. President Hornberger did not reply.
- A parent complained that her daughter's 4th grade teacher misinformed the children and they were directed to write letters to the new Principal. The Superintendent of Schools stated that no teachers were told to say that the Principal was subbing at another building.
- ❖ A parent commented that there was a problem in how the Board and the Superintendent of Schools handled this situation with parents and staff and now it needs to be handled better because it is affecting the children. The Superintendent of Schools stated he will address it with the 4th grade teachers.
- A parent stated that her child cried, and that everyone on the dais had issues at some point.
- A parent complained that the 5th grade students left for their trip and because the Principal was not there to see them off they new something was wrong. The parent stated that rumors were flying and they want answers. The parent stated that they miss this Principal, who is loved by the parents and faculty, and stated they will fight for this Principal.
- A parent stated this is highly unusual and thinks they need to know more. A person is innocent until proven guilty. This situation was handled badly. The parent wants the teachers told what they can tell the children.
- Mr. McGrath needed clarification as to what was told to the children.
- ❖ A parent stated that her child thinks the Principal is on vacation, but many think the Principal was fired. The 5th grade students are all talking about this experience and wondering why the Principal left without telling them, because all the parents know their Principal would not go without saying something. The Principal knows every single child as well as what their likes and dislikes are. This parent has never known the Principal to be anything other than professional and respectful with everyone. They also feel this should have been done another way because the children are

- devastated, the climate of the school is different, and she wants to know when the Principal will return.
- ❖ A parent feels the children's interest is first and foremost and they deserved honesty. She also complained about the way information was disseminated to the faculty and staff.
- A parent inquired as to dealing with students. The Superintendent of Schools stated he will be speaking with the Principal's temporary replacement as to what is happening. A parent requested the parents be told before the children. The Superintendent of Schools stated that they are trying to protect the children. He does not believe the teachers are being malicious. We are asking you to respect the process and privacy of the individual until it comes to an end. The Superintendent of Schools stated that this is a personnel matter and the parties involved have a right to privacy and not speak to anyone else is their right, it is a courtesy, because he knows first hand what it means to speak on individual matters. He further stated the children should not be given mixed messages.
- ❖ A parent made a comparison between the removal of the Principal, and litigation against the former Superintendent of Schools and that he was able to keep his position. The parent further stated that out of respect for the Principal they should have had the same opportunity as the former Superintendent of Schools to explain why. The parent stated she, her fellow parents, and children want the Principal back.
- ❖ A parent asked Mr. McGrath, as an attorney, if it was a personnel matter or legal matter. Mr. McGrath stated there was no difference. The parent inquired as to a time frame. The Superintendent of Schools responded that the Principal is still a Principal of the building, but she is not there at this time. Even though they are not there a placeholder is there until the issue is resolved. The situation needs to be resolved and requested that the parents not to jump to conclusions, the district is trying to protect the individuals involved.
- ❖ A parent requested that the district make the social worker available for the children. The Superintendent of Schools stated it was a good point.
- A parent stated that the teachers did the best job they could to explain the Principal's absence and does not want it reflected badly on them.
- A parent inquired as to the legal expenses. Mr. Hornberger responded the district was paying for them.
- ❖ A parent stated that the taxpayers were paying and speculated to the severity of the situation. The parent also stated that the Principal always presents themselves as a professional person and expressed the frustration in not jumping to conclusions. He further stated the Principal does a great job.
- A parent stated the parents were not here tonight to attack the Board, but to respectfully get a better understanding of the situation. The Superintendent of Schools stated he did not get the impression of being attacked. Mr. McGrath responded that he certainly did not feel attacked, because this audience handled themselves with remarkable restraint. He is optimistic this situation will be resolved by the next Board of Education meeting and the parents will not need to hear from the attorney.

President Hornberger made the following announcements: Homecoming rescheduled to October 18, 2009. The Superintendent of Schools stated that if the weather is inclement a decision will be made early and ConnectEd will get the message out. A resident inquired about refreshments for that day and the Superintendent of Schools responded not to plan for that. Mr. Hale inquired about another date. The Superintendent of Schools responded that there are no other home games on the schedule.

At this time Mr. Peter Freeman made a Fine & Performing Arts presentation. He discussed the following: 3 components of the program (Art, Theatre, and Music); Art instruction being offered in Pre-Kindergarten continuing through Elementary, Middle School and High School; display of artwork throughout the district, around the community, honors shows i.e. All-Nassau County Art Exhibit; performance of musicals, talent shows, and dramas; "Casts of Thousands", a place for all students in cast, crew, and pit orchestra; activity giving students poise and confidence; musical instruction throughout elementary school beginning in grade 3; Middle School has a band, orchestra, chorus, chamber and jazz ensembles; High School music features concert, jazz and marching band, mixed, treble, jazz and select choirs, and symphonic and chamber orchestras; improvements in marching band participants; increased number of students attending NYSSMA Solo Festival; increased top scores from 46% to 50% on levels 1-4 and from 87% to 89% on levels 5-6; more students accepted into Honors Ensembles i.e. All-County, LISFA, and All-State; what makes Mineola one of the Best Communities for Music Education. Mr. Freeman presented to the Board a certificate from NAMM Foundation for outstanding support to music education in 2009. Mr. McGrath inquired about how student progress is shown. Mr. Freeman will put together an analysis of scoring. The Superintendent of Schools stated that its part of the annual report. He will be addressing the statistics at the next meeting.
