The Board approved the student discipline recommendations as presented.

Mrs. Tierney highlighted the work done by the West Shore Foundation and announced the Foundation's plans for a special event in October 2016.

Mrs. Crocenzi shared information from the Intermediate Unit meeting she attended.

Mr. Kambic highlighted a recent Board visit to Cedar Cliff High School and upcoming events at Cumberland Perry Area Vocational Technical School (CPAVTS). He also shared the names of those CPAVTS students recognized during the last marking period for academic excellence.

Mrs. Grover reminded Board members that this is the last year of the Harrisburg Area Community College agreement.

Mrs. Williamson shared exciting things going on at Fishing Creek Elementary School including an initiative in which students are teaching each other. She also thanked the Red Land High School Field Hockey team for inviting her to attend their banquet.



He also thanked AFSCME for approving an agreement that will assist the District in maintaining long-term financial stability.
