

**CALVERT HIGH SCHOOL
STUDENT PARKING RULES & REGULATIONS**

1. Attendance and chronic tardiness may result in a loss of parking privileges.
2. Students who are issued parking permits must park their vehicle in an appropriate space & lot within the student parking lot. Students may not park in the STAFF and/or KISS and RIDE lots (front of school). The hang tag must be visible in the front windshield of your vehicle.
3. Upon arrival at school, student drivers must immediately exit their parked vehicle and may not loiter in or around their vehicle or any other vehicle. The same rule applies when student drivers are dismissed at the end of their school day.
4. No loud music is allowed while on school property.
5. Once students have parked, they may not return to their vehicles during the school day, including lunch, without a pass from a school administrator. No teacher may grant such permission to a student. Students returning to their vehicle without proper authority will have their parking permit suspended or revoked.
6. The student and his/her parents acknowledge that they are aware that Calvert County Public Schools, its Board of Education, and Calvert High School do not assume any responsibility for damage or theft involving vehicles parked under this agreement. To that end, students are encouraged not to leave any valuables in their vehicles and to remove their keys and lock their vehicles after parking them.
7. The student acknowledges that he/she will be held personally responsible for any contraband discovered within their automobile, regardless of ownership of the vehicle. To that end, student drivers will ensure that no weapons of any type, alcohol, tobacco products or controlled dangerous substances are stored in any vehicle they park on school property.
8. School officials have the authority to search students under their jurisdiction without a warrant when there are reasonable grounds for suspecting that the search will reveal evidence that the student has violated or is violating either the law or school rules.
9. No student will be issued a parking permit until ALL financial obligations are satisfied.
10. By entering this agreement, the student and the parent/guardian acknowledge that they understand, and that the student agrees to comply with all provisions of it. The student and parent/guardian acknowledge that any violation of this agreement will result in the suspension of the student's parking privilege, in addition to any other sanctions imposed under the Student Code of Conduct. **THERE WILL BE NO REFUND OF MONIES SHOULD PARKING PRIVILEGES BE REVOKED.**

**Seniors and Juniors take precedent for parking passes. Sophomores will be given the opportunity to purchase parking passes once Seniors leave on May 17, 2024.
NO PARKING PERMITS WILL BE ISSUED TO FRESHMEN.**
