

#### THE BACKSTORY

- THE YOUNG LADY WAS SCREAMING BECAUSE SHE FEARED LOSING EVERYTHING THEY HAD.
- THE FIRE WAS CONTAINED MOSTLY TO ONE AREA OF THE HOUSE
- THE FIREFIGHTER WAS SMILING BECAUSE:
  - HE SAY ME PHOTOGRAPHING THE EVENT
  - HE HAD JUST COME OUT OF THE FIRE, WHERE PART OF THE ROOF COLLAPSED WHILE HE WAS IN, MADE IT
    OUT OK AND WAS HEADING TO A MANDATORY COOL-DOWN STATION ACROSS THE STREET.

#### EDITORIAL DECISONS

- PHOTOGRAPHERS HAVE TO MAKE SPLIT SECOND DECISIONS WHETHER TO TAKE A PHOTOGRAPH
  OR NOT. THEY ALSO HAVE TO MAKE A DECISION ABOUT WHICH PHOTOS THEY WILL SUBMIT TO
  THEIR EDITOR OR PUBLISHER FOR INCLUSION IN AN ARTICLE,
- EDITORS AND PUBLISHERS MAKE THE FINAL CALL ABOUT WHICH PHOTO OR PHOTOS ARE USED IN AN ARTICLE.

TODAY WE ARE GOING TO EXAMINE A CASE WHERE THE DECISION TO TAKE AND THEN USE A PHOTO OF A TRAGEDY HAD SOME CONSEQUENCES FOR A PHOTOGRAPHER AND NEWSPAPER EDITOR.
