

The following questions will appear on the Point Pleasant Preschool Enrollment Request Form, which will be open on <u>Saturday, July 13, 2024 from 9:00 AM - 4:00 PM.</u>

Please remember that enrollment will be first-come, first-served.

- Parent/Guardian's full name, primary phone number, and mailing address
- Student's full name, birthdate, gender
- Is the student a multiple (twin, triplet, etc.)? If yes, please be sure to complete an Enrollment Request Form for each multiple child.
- What was the first language used by the student? At home, does the student hear or use a language other than English more than half of the time?
- Your child may be eligible for additional educational services through the Federal McKinney-Vento Act.
 Eligibility can be determined by completing this question. Presently, are you and/or your family living in any of the following situations?
 - Staying in a shelter (family shelter, domestic violence shelter, youth shelter) or FEMA trailer.
 - o Sharing the housing of others due to loss of housing, economic hardship or similar reason.
 - o Living in a car, park, campground, abandoned building, or other inadequate accommodation.
 - Temporarily living in a motel or hotel due to loss of housing, economic hardship or similar reason.
- Your child may be eligible for additional educational services due to income eligibility status. Eligibility
 can be determined by completing this question. Please check all of the following that apply:
 - Your family receives NJ SNAP benefits (food stamps)
 - Your family receives TANF (Temporary Assistance for Needy Families)
 - Child who would be enrolled in preschool is on Medicaid
 - Child who would be enrolled in preschool is currently your foster child
- Does your child currently receive any of the following support services? Please check all that apply.
 - Speech therapy, Occupational therapy, Physical therapy
- Parent/guardian completing the enrollment request form will be asked to acknowledge the following:
 - If your child is offered placement in the Point Pleasant Preschool Program, a parent/guardian will be required to complete registration IN PERSON. The following documents must be provided at the time of registration:
 - Photocopy of child's birth certificate
 - Photocopy of current deed or lease indicating a Point Pleasant Borough address
 - Photocopies of three current documents showing a Point Pleasant Borough address
 - Photocopy of child's immunization records to date
 - I understand that completion of this Point Pleasant Preschool Enrollment Request Form does not guarantee enrollment for my child.
 - I understand that the Point Pleasant Preschool Program will operate on a schedule that is five days per week, six hours per day, and there is not an option for half-day enrollment. Preschool students will follow the district calendar and adhere to district attendance policies.
 - I understand that if offered enrollment, my child is not guaranteed placement at our home school based on residence.
 - I understand that my child's school start and end times will be determined based on my child's assigned school and available transportation, and I will be informed of the start and end times of my child's school day if offered enrollment.
