

What is PVAAS Teacher Specific Reporting?

- Estimates the effect of a teacher's performance on the academic growth of a group of students.
- Provides a measure of academic growth for students by taking into account both their endpoint and their entering achievement level.
- Provide a diagnostic feedback to teachers regarding their influence on the academic growth of students.
- Provide a teacher-specific growth measure to be used as part of the PA Educator Effectiveness System.





PVAAS does <u>NOT</u> compare the percentages of students at various PSSA performance levels to measure growth!

What is PVAAS Teacher Specific Reporting?


Part of Teacher Effectiveness System of Evaluation

- Focuses on the Teacher Specific Reporting
- 15% of the overall evaluation
- After three consecutive years of PVAAS specific reporting in any tested subject, grade, or course teachers will receive a 3 year rolling average.
 - Tested subject area or course does not need to be in the same area or grade
 - Used in the 2016 Evaluation

What Should Teachers Expect?

- PVAAS teacher specific data will not be included as a part of the summative evaluation rating until a teacher has a PVAAS 3-year rolling average – based on 3 consecutive school years of PVAAS teacher specific reporting.
- PVAAS teacher specific reporting from a single school year or two single consecutive school years will not be used on a teacher's final rating form.
- School year 2013-14 is Year 1 of the 3-year rolling average.
 - First used as part of the Teacher Specific Data (15%) at the end of the 2015-2016 school year.

What is PVAAS Roster Verification?

- Process in which Administrators and Teachers work together to make sure that the right students are linked to the right teachers for each of the PA State tested areas in grades 4-12 for the right amount of instructional time for the Teacher Specific Reporting.
 - Grade 4: PSSA Reading, PSSA Math, PSSA Science
 - Grade 5: PSSA Reading, PSSA Math, PSSA Writing
 - Grade 6: PSSA Reading, PSSA Math
 - Grade 7: PSSA Reading, PSSA Math, Algebra I Keystone
 - Grade 8: PSSA Reading, PSSA Math, PSSA Writing, PSSA Science, Algebra I Keystone
 - Grades 9-11: Algebra I Keystone, Biology Keystone, Literature Keystone

Who is Responsible for Completing the PVAAS Roster Verification?

- Regular Education and Special Education Teachers who work within Domain 1 AND Domain 3 of the Danielson Framework have a reportable Percentage of Instructional Responsibility for a student that is dependent on the time allotment.

 - April 28th May 4th: Administrative Preview of Class Rosters
 - May 5th May 18th: Teacher Roster Verification Window
 - May 19th June 1st: School Administrator Review of Teacher Roster Verification
 - June 2nd June 8th: District Administrator Review of Teacher Roster Verification
