_____ **BYRD SCHOLARSHIP:** Applicant must have a 2.667 GPA, letter in at least one sport, participate in school activities, and demonstrate good citizenship.

_____ **BYRD FAMILY SCHOLARSHIP:** Applicant must attend the University of Missouri. Applicants with financial need are preferred. Applicants enrolling in the Trulaske College of Business, College of Education, or students majoring in a STEM program are preferred.

_____ **CANEPA FAMILY SCHOLARSHIP:** Applicant must have a 2.667 GPA, be a good citizen, and show need for financial assistance.

_____ **MURRELL GODWIN MEMORIAL SCHOLARSHIP:** Applicant must have a 2.667 GPA, participate in school and community activities, demonstrate good citizenship, and have participated in at least one year of high school athletics.

_____ **MORRIS AND ROSALIND GOLMAN SCHOLARSHIP:** Applicant must have a 2.333 GPA, be a good citizen, have financial need, and score advanced or proficient on all EOC exams taken during grades 9 through 12.

_____ **RONALD CHARLES & RODGER NEAL HERRINGTON MEMORIAL SCHOLARSHIP:** In memory of an African-American, this scholarship recipient must have a 2.667 GPA, show leadership and participation in school, community and church activities, and demonstrate good citizenship.

_____ **WINT JOHNSON SCHOLARSHIP:** Student must have a 2.667 GPA, intend to pursue a career in journalism or a related field, and show leadership in school activities.

_____ **LIEUTENANT KENT M. KIEPE SCHOLARSHIP:** Student must exhibit progressive self-improvement throughout seven semesters, have at least a 2.667 GPA, be physically fit and participate in athletics their senior year, and be a leader in school and community activities.

_____ **GLADYS AND HOWARD LITTON SCHOLARSHIP:** Student must rank in the top half of his/her class and intend to pursue a career as a classroom teacher.

_____ **MATTHEW M. LUCAS MEMORIAL SCHOLARSHIP:** Candidates should have a 2.667 GPA, be a good citizen, have financial need, and exhibit friendliness, helpfulness, respect, and a care of others. Preference will be given to students who plan to pursue a career working with young children.

_____ **MAURICE O. LUCAS FAMILY SCHOLARSHIP:** Candidates should have a 3.00 GPA after seven semesters, be a good citizen, have financial need, have a solid goal/reason for wanting to continue their education, and have leadership/participation in school/community/church. SPECIAL NOTE: Financial Need shall be weighted above the others.

_____ **ADAM AND WILLA MCCULLOUGH SCHOLARSHIP:** In recognition of two outstanding African-American educators, applicants must have a 2.333 GPA and show a need for financial aid.

_____ **THE ROSE MARY AND PAUL TOM POOLE SCHOLARSHIP:** Student must have a 2.333 GPA and demonstrate participation in school and community activities.

_____ **SEYVEE SIRINTRAPUN MEMORIAL SCHOLARSHIP:** Applicant must have a 2.667 GPA, participate in school and community activities, and demonstrate good citizenship.

_____ **KAREN TESREAU TRUST SCHOLARSHIP:** Student must plan to pursue a degree in music.

_____ **JOANN THURMAN-MANGAN DRAMA SCHOLARSHIP:** Student must demonstrate excellent character and have a minimum 3.0 GPA. Participation in school plays is preferred.

_____ **RALPH B. TYNES SCHOLARSHIP:** Student must have financial need, rank in the upper one-half of the graduating class, enroll as a full-time student in a state supported two-year or four-year Missouri college, and exhibit leadership in school and community.

_____ **VINYARD SCHOLARSHIP:** Student must have at least a 2.667 GPA, participate in school and community activities, and demonstrate good citizenship.
