Mr. Edwards spoke about the Finance Report. He said that revenue is up when comparing this April to last April. He also said that expenditures are slightly up from this April to last April. He said Gross Production is continuing to come in really well and that the district's carryover will be relatively the same as when we started the 2017-18 school year. He said we have collected monies from Federal Program claims and will continue to collect as the school year comes to an end.

Ms. Greenway is very deserving of this award and much appreciated.

Dr. Herron said that it really says a lot when you receive a standing ovation from your students, which is exactly what happened when Mr. Voyles was announced as Teacher of the Year. Mr. Voyles decided he wanted to teach and went back to college to do just that. He is a 7th grade language arts teacher at CMS. Mr. Voyles will be applying for Oklahoma Teacher of the Year as well.
