Subject: CTE Certification Summary for the 2018-2019 School Year
Date: August 29, 2019

Recent industry credentialing initiatives through Career and Technical Education encourage students to work toward earning an industry certification, achieving a State licensure, or passing an occupational competency assessment while pursuing a high school diploma. To graduate with a Standard Diploma, a student must earn at least 22 standard units of credit by passing required courses and electives, and earn at least six verified credits by passing end-of-course SOL tests or other assessments approved by the Board of Education. Beginning with students entering ninth grade for the first time in 2013-2014, a student must also earn a board-approved career and technical education credential to graduate with a Standard Diploma and successfully complete one virtual course, which may be non-credit bearing. The class of 2017 was the first class required to meet these new requirements. All seniors graduating with a Standard Diploma succeeded at meeting this requirement.

During the 2018-2019 school year, students in CTE classes passed 1358 licensure or certification exams. This number of 81% passing is up compared to the 1411 certifications earned in 2017-2018 with a 80% pass rate, 1505 certifications earned in 2016-2017, 1471 certifications earned in 2015-2016, 1421 earned in 2014-2015, 1396 certifications earned in 2013-2014, 864 earned in 2012-2013, 466 earned in 2011-2012, 301 earned in 2010-2011, 180 earned in 2009-2010, 102 earned in 2008-2009 and 32 certifications during the 2007-2008 school year. A total of 1,677 certification or licensure exams were given to students during the school year. A summary of exams given at the four high schools and the Career Tech Center are shown below.
