I. CALL TO ORDER

Chairman Laura Pitone called a Regular Meeting of the School Committee to order in the aldermanic chambers at 7:02 p.m., with a moment of silence and a salute to the flag of the United States of America. Ms. Pitone asked for a roll call, the results of which are as follows: - Present - 6 - Futrell, Roix, O'Sullivan, White, Green and Pitone and Absent - 3 - Curtatone, Palmer and Normand.

II. STUDENT ADVISORY COUNCIL – Mr. Domond was not in attendance this evening.

Ms. Pitone announced that she would be taking several item out of order, unless there was objection.

NEW BUSINESS

A. Joint Signing of Integrated Contract of the SCALE Employees Union, Unit D STA

Ms. Pitone announced that she is pleased to welcome two members of the SCALE Employees Union, STA, Unit D to join her at the front of the horseshoe to sign the integrated contract for their unit. Ms. Laura Brooks and Ms. Constance Devanthery Lewis, along with Ms. Pitone, signed three copies of the agreement. Members applauded and thanked the women for attending this evening.

REPORT OF SUPERINTENDENT

A. Presentations:

- School Improvement Plans
 - Somerville High School

Ms. Pitone announced that our next item of business will also be taken out of order and invited Superintendent Skipper to introduce Mr. John Oteri, Headmaster at Somerville High School, as he presented his School Improvement Plan. Mr. Oteri began by introducing his "dream team" of School Council and staff members. He is proud that Somerville High School has been a Level I School for four years and stated that, like the Patriots, they are also in pursuit of their own 5 rings! The presentation (slides at end of these minutes) included the following:

- Sustaining success
- Academic focus on lack of student achievement and the link to attendance. Staff have also conducted a survey of students in an attempt to ascertain reasons for both absence and failure.
- The goal of decreasing failure rates by at least 50% for SY18
- Action steps
- A focus on ELL MCAS Math performance and next steps for improvement
- A Wellness Focus around food access and the development of an action plan to address any issues where hunger creates issues for students.

Following the presentation, discussion ensued which included the following:

- Fantastic job on presentation, especially data
- Food access issues
- Ninth Grade Experience continuation throughout the grades to follow at-risk students
- Scheduling of electives is it difficult for students to still be active in music, art, when they are trying to fit in the core subjects?
- The need for a Registrar at SHS.
- How many students who take Exploratory stay in CTE program?
- Reasons for ELL MCAS differential?
- Thanks from all members for everyone's attendance this evening and the great presentation.

The School Committee meeting recessed at 8:01 so members could thank and interact with the attendees.

The meeting resumed at 8:10 p.m.

One more item was taken out of order, the matter of clarification on protections for transgender students. Director of Student Services, Richard Melillo, stepped to the podium and informed members that all students who have identified as transgender have access to unisex bathrooms or may use the bathroom he/she identifies with. This is true at the high school level. There is not a firm procedure in place at the elementary level, as yet.

Students have had training relative to "Respect and Accept".

No policy in our manual regarding this topic, but the matter can be taken up at a future Rules Management Subcommittee meeting.





Academic Focus: Student Course Failures 2015-2016


Failure Percentages by Level




Total Student Numbers




Total Number of Class Absences for Students who Failed by Subject

 Attendance will improve, students will receive the academic support that they need, and failure rates in CP and CPS classes will drop and students will be more confident learners.

The failure rates for students with 0-9 absences in CP and CPS classes will decrease by at least 50% for SY18.

Action Steps


- Instruction: Professional development, regular collaboration with teachers and Special Ed, and case conferences with students and guidance


