### **SUPERINTENDENT'S REPORT:**

### Spotlight on Students:

Dr. Chamberland introduced Bryn Mawr Principal Brooke Beverly, to discuss the service learning projects the students have conducted.

Brooke Beverly introduced Mary Johnson, 1st grade teacher at Bryn Mawr, as well as 2nd grade students Mackenzie Kruckas and Gracyn O'Brien. The students talked about Collecting Food at Thanksgiving, Kindness Day on November 14th, Giving Tree, Holiday Wreath Stroll at Eddy Pond Assisted Living Facility, and the Mitten Tree. ### **UNFINISHED BUSINESS:**

## **COVID Update**

Dr. Chamberland reported 18 positive COVID cases since returning from the Winter break. She stated the district is doing all we can to clean and provide masks. SHe asked parents to please keep students home if they are not feeling well.

#### FY 24 Budget

Dr. Chamberland:The FY 24 draft budget presented to you over the last several meetings represents a 4.35% increase from the amended FY 23 School Budget. This 4.35% reflects an increase from the FY 23 Amended Budget amount of \$28,973,070 to the FY 24 Draft Budget amount of \$30,232,276.66 for an overall increase of \$1,259,206.66.

Jessie Harrington: We are aware that people have concerns regarding the Intensive Special Needs classroom at Swanson Road.

Meghan McCrillis read aloud a letter from Kathy King, located at Pakachoag, in support of the ISN room at SWIS.

Dr. Chamberland: Swanson Road did have an ISN room a few years ago. That room was closed due to the majority of the students who utilized the room transitioning to middle school. The remaining students also moved to the middle school because of the small number, setting and seasoned teacher. This position to hire a teacher to reinstate the ISN room at Swanson Road has been in every presentation of the FY24 budget. The need has increased.

Jessie Harrington: The classroom is coming back!

Jessie Harrington entertained a motion to approve the FY 24 draft budget number of \$ 30,2132,276.66 be sent to the Town Administration for further review and approval.

### **Tiered Focus Monitoring Summary**

Dr Chamberland: In your packet you will find information summarizing the full approval of all information provided to DESE related to the Tiered Focus Monitoring visit that began last winter. Corrections have been made and accepted by DESE, which completes this monitoring cycle. As noted in the email also included in your packet, the district's next scheduled activity is a Group A Tiered Focused Monitoring (TFM) review, which focuses on Student Identification, IEP Development, Programming & Support Services, and Equal Opportunity. This visit is usually carried out three years after the Group B TFM review, and we anticipate that the next onsite visit will take place during the 2024-2025 school year. All Massachusetts Public School Districts are included in each of these monitoring cycles.
