LIFE Lessons Essay Contest

Amount: \$5,000-\$15,000

Criteria: Must be between the ages of 17-24 and have suffered the death of a parent or guardian. Must be a legal U.S. resident and been accepted to a college, university, or trade school. Must submit a written essay of up to 500 words OR a short three-minute video essay about how the loss affected them emotionally and financially. The essay should indicate whether having (or not having) life, health and other forms of insurance helped stabilize family finances and cover college costs.

NC Alpha Delta Kappa Student Achievement Scholarship

Amount: Not specified

Criteria: This scholarship will be awarded to graduating seniors who plan to pursue a degree at a school of higher learning. To be eligible, applicants must have a weighted GPA of 2.5 to 3.5 and an SAT score (including Math, Verbal, and Writing) in the range of 1020-1290 OR an ACT composite score between 20 and 24. Students with a lower or higher GPA/test scores will NOT be considered. Applicants are also judged based on their service to school, community, and church, as well as their integrity and leadership potential.

Amount: \$500

Criteria: This \$500 scholarship is available to students in pursuit of a higher education in the fields of agriculture, horticulture, home economics, or related areas such as forestry, ag-mechanics, welding, and child-care. Preference will be given to Future Farmers of America members and Future Homemakers of America members. Applicants must be seniors or past graduates of Union County Public Schools.

Amount: Not specified

Criteria: The Marine Corps Scholarship Foundation's scholarships are for children of Marines and Navy Corpsmen pursuing a post-secondary education at any accredited school, whether it's a career training or trade school, community college, or four-year university. There are financial need scholarships and award scholarships for every eligible applicant.

Criteria: This fund provides scholarships for children of Mecklenburg County police, fire, MEDIC, and sheriff first responders. Scholarships are awarded based on academic merit, financial need, and community service. The applicant's parent must be a full-time employee of the Charlotte Fire Department, CMPD, Mecklenburg County Sherriff's Office, or MEDIC, with at least one year of service. Applicants must have a minimum 2.5 GPA and plan to enroll at an accredited two-year or four-year school upon graduating high school.

Blumenthal Performing Arts Gordon Hay Scholarship

Amount: \$5.000

Criteria: This scholarship will be awarded to one senior who plans to pursue a non-performing career in the performing arts field. Applicants must meet the following criteria: 1). Excellent academic performance; 2). Aims for personal excellence; 3). Committed to school and community engagement; 4). Yearns to enrich other's lives through performing arts; 5). Potential for career success in a non-performance area of performing arts which is evidenced by a portfolio and references; and 6). Proof of enrollment/acceptance at a four-year accredited college or university for a non-performance area of performing arts, such as Music Composition or Musical Direction; Orchestration; Choreography; Play Writing; Set, Costume, Lighting or Sound Design; Arts Administration; Stage Management; Production Management; Technical Direction. Financial need will also be considered. In addition to completing an application, students must complete and submit a Free Application for Federal Student Aid (FAFSA), a one-page essay (topic found on the website below), two references from two performing arts teachers, and a copy of their high school transcript.

Michael A. DeMayo Scholarship

Amount: \$2,500

Criteria: To be eligible, you must be a current high school (or home-schooled) senior who attends school in Union County, who has been accepted to or has plans to attend a four-year university, and has a cumulative GPA of at least 3.0. All applicants must submit a single package with following items included: (1) Scholarship application that is typed or neatly printed (forms can be found in guidance), a recent photo must be attached with the form, (2) a presentation (video/PowerPoint/brochure/website/essay) that encourages fellow teens to abstain from underage drinking and driving and/or highlights the dangers of drinking and driving, (3) official or unofficial high school transcript (must include class rank, size, and test scores), (4) SAT/ACT scores (if not included in transcript, a printout from CollegeBoard.com is acceptable), (5) and two letters of recommendation (from school, club, or community leaders) that assess the applicant's academic potential, his/her progress and academic achievements, community/school involvement, or volunteer activities. All of these items must be turned in at the same time. Items submitted separately will not be accepted.

Criteria: To be eligible, students must be a U.S. resident; have a minimum 3.75 GPA; rank in the 90th percentile in both math and critical reading on SAT I or composite ACT scores; and plan to pursue an engineering or related science degree through an ABET accredited program.

Have an ACT Composite of 24 and/or SAT score in Math - 600 or above and in Critical Reading - 550 or above. Students should submit an official high school transcript, two letters of recommendation, SAT/ACT scores, a completed FAFSA application, and an essay that outlines your financial need and career interest. Please note: preference will be given to Kettering University students.

Amount: \$250, \$500, \$1,000, and a \$5,000 scholarship to the New York Film Academy for first place winner Criteria: To enter, students must submit a four-minute film on this year's theme: "Watch What You #Tweet! How free should social media be?" In addition to the film, students must also submit an application and a report that explains the intent of the film, the creative process, and technical accomplishments. This report should be approximately 250 words in length. To be eligible, students must be younger than 19 years old and reside in the United States.

Amount: \$2,500 over two academic semesters

Criteria: The Ulman Cancer Fund assists students that have been diagnosed with cancer, or who have a family member diagnosed with cancer, with paying for post-secondary education. Several scholarships are available, and most of them have specific criteria. As a general rule, students must have been at least 15 years old at the time of diagnosis to apply. Scholarships will be awarded for \$2,500 over two academic semesters. Students only need to complete one application and will be considered for all scholarships in which they meet the criteria. Please note: Scholarship recipients **are obligated to organize and run a bone marrow registry drive with the support of Delete Blood Cancer and There Goes My Hero.**

Amount: \$2,000

Criteria: Open to young women planning to enroll in a four-year college or university in North Carolina next fall. To be eligible, applicants must: 1). Have submitted an application to their college of choice; 2). Be ranked in the top 10% of their senior class; 3). Have a minimum 1220 SAT score or minimum 20 ACT composite score; 4). Participate in extracurricular activities in the school and community; and 5). Demonstrate good character. Financial need is not a primary consideration. Along with the application, students must submit a high school transcript, two letters of recommendation, and a personal statement. Applications are available in the Guidance Office

The Mary Rolls Mills-Linda Ranking Memorial Scholarship

Amount: \$2,000

Criteria: open to any student who is planning to enroll in a four-year college or university in North Carolina next fall. To be eligible, applicants must: 1). Have submitted an application to their college of choice; 2). Be ranked in the top 10% of their senior class; 3). Have a minimum SAT score of 1290 or ACT composite score of 22; 4). Participate in extracurricular activities in the school and community; and 5). Demonstrate good character. Financial need is not a primary consideration. Along with the application, students must submit a high school transcript, two letters of recommendation, and a personal statement. Applications are available in the Guidance Office.

The Clare Johnson Marley-Mary Earle Berger Fine Arts Scholarship

Amount: \$2,000

Criteria: open to any student who is planning to enroll in a four-year college or university in North Carolina next fall and plans to declare a major in the fine arts. To be eligible, applicants must: 1). Have submitted an application to their college of choice; 2). Be ranked in the top 20% of their senior class; 3). Have a minimum 1650 SAT score or minimum 20 ACT composite score; 4). Participate in extracurricular activities in the school and community; and 5). Demonstrate good character. Financial need is not a primary consideration. Along with the application, students must submit a high school transcript, two letters of recommendation, a personal statement, and a CD/DVD demonstrating proof of talent. Applications are available in the Guidance Office.

The Mary Doctor Performing Arts Scholarship Fund

Amount: \$10,000

Criteria: To be eligible, students must: 1). Have a GPA of 2.5 or higher; 2). Have financial need; 3). Demonstrate an interest and ability in one or more areas of performing arts; 4). Plan to pursue an undergraduate degree in music, dance, theatre, technical theatre, arts administration or teaching; and 5). Be able to provide proof of acceptance to a college or university with a performing arts program with the intentions to enroll full-time. In addition to completing and submitting an application, applicants must: 1). complete and submit the Free Application for Federal Student Aid (FAFSA); 2). Complete a one-page essay entitled, "Why I Am the Right Choice for the Mary Doctor Performing Arts Scholarship"; 3). Provide a reference from at least two performing arts teachers; 4). Provide an official transcript; 5). Provide a copy of your 2017-2018 Student Aid Report (SAR); and 6) Include a copy of a college acceptance letter and any financial aid reward letters received. Rosa L. Poston and Jeanette B. Sherrod Scholarship

Amount: Not specified

Criteria: The Union County Alumnae Chapter of Delta Sigma Theta Sorority, Inc. will be awarding two scholarships to high school seniors in Union County. Applicant must submit an acceptance letter from at least one accredited four-year college or university, they must have a GPA of at least 3.0, they must have the potential for post-secondary education (academic performance and/or SAT/ACT scores), they also must have leadership potential as evidenced by their school or community activities. Applicants must submit the completed application packet along with two letters of recommendation (one from a school official and one from an adult who is not a relative), a sealed official transcript, and a copy of the most recent SAT/ACT scores, a typed essay of no more than 250 words stating why you are applying for the scholarship, your qualifications, and your educational and career goals. Criteria: Eligible applicants need to complete the application packet and include the following documents: Official high school transcript, copy of acceptance letter from an accredited college/university or community college, three letters of recommendation (two from school personnel and one from a community representative), and a completed essay. Quest Bridge College Prep Scholars Program

Amount: Not specified

Criteria: This program helps high-performing low-income high school juniors get an early advantage in college admissions by connecting them with full four-year scholarships or generous financial aid to attend Quest Bridge's college partners. Juniors who are eligible are typically in the top 5-10% of their class, earning mostly A's in their challenging coursework, whose family earns less than \$65,000 annually (for a typical family of four) with minimal assets. Hispanic Scholarship Fund

Amount: \$500-\$5,000

Criteria: To be eligible, students must: 1). Be of Hispanic Heritage; 2). Have a minimum 3.0 GPA; 3). Plan to enroll full-time at an accredited not-for-profit, 4-year university in the fall; 4). Be a U.S. citizen, Permanent Legal Resident, DACA or Eligible Non-Citizen (as defined by FAFSA); and 5). Complete the FAFSA. All majors of study will be considered, but there is an emphasis on students majoring in STEM fields.

Criteria: Scholarships are available for students training to become automotive, heavy duty or collision repair technicians, and to students in business, marketing, engineering, or other major courses of study. The Global Automotive Aftermarket Symposium (GAAS) and more than 30 additional organizations award automotive scholarships. All you need to do is complete one application and you will be considered for all scholarships in which you meet the eligibility criteria for. In addition to your application, you will need to provide: a one page essay stating your career goals, one letter of reference, and your high school transcript. There is no minimum GPA requirement.

Amount: \$2,500

Criteria: Students should use their imagination to become a superhero or supervillain and think about how you would use your powers for a day. In 250 words or less, students should answer this question: "Which superhero or villain would you want to change places with for a day and why?" To be eligible, students should be at least 13 years old, a legal resident of the United States, and be planning to enroll in a post-secondary institution by the fall of 2023.

Veterans of Foreign Wars Creative Patriotic Art Awards

Amount: 1st place: \$10,000; 2nd place: \$5,000; 3nd place: \$2,500; 4th place: \$1,500; 5th-8th place: \$500. **Criteria:** Applicants must express patriotism in art form. The contest rules are: Art must be on paper or canvas. Water color, pencil, pastel, charcoal, tempera, crayon, acrylic, pen-and-ink, or oil may be used. Digital

canvas. Water color, pencil, pastel, charcoal, tempera, crayon, acrylic, pen-and-ink, or oil may be used. Digital art and photography are not accepted. Do not frame your artwork. Submit canvas entries on stretcher frames or canvas board. Other entries must be matted on white. Do not use other color mats. In matting, use heavy paper to reinforce back. Mounted and floating mats may also be used. The art should be no smaller than 8"x10" but no larger than 18"x24", not including mat. Be sure to complete the entry form and attach to back of entry. You must be sponsored by a VFW Auxiliary. Entry may be signed by the student. If you use an Amerian Flag in the entry, it must conform to the Federal Flag Code as far as color, number of stars and stripes, and other pertinent rules of the code. Entry must have been done during the current school year. You must have your teacher's or supervisory adult's signature. Each student may submit only one entry. Eligible students must be in grades 9-12 and must attend a school in the same state as the sponsoring VFW Auxiliary. Students must be no older than 18 years at the time of entry. You must be a U.S. citizen or U.S. national.

Amount: Full tuition and fees (uncapped) OR room and board (capped at \$10,000/year) a monthly stipend (\$300-\$500), an annual \$1,200 book stipend, and monthly E5/Cadet Drill Pay through Army ROTC Simultaneous Membership Program.
