FOCUS REPORT - Leveled Literacy Intervention Data Collection Report for 2009-2010 - Mrs. Skorapa

Mrs. Skorapa reported on results for Brunswick students enrolled in the Leveled Literacy Intervention (LLI) program. She said a majority of those in the program showed significant progress.
